4	SECTION 1. Subchapter A, Chapter 552, Government Code, is
5	amended by adding Section 552.0031 to read as follows:
6	Sec. 552.0031. BUSINESS DAYS. (a) Except as provided by
7	this section, in this chapter "business day" means a day other than:
8	(1) a Saturday or Sunday;
9	(2) a national holiday under Section 662.003(a); or
10	(3) a state holiday under Section 662.003(b).
11	(b) The fact that an employee works from an alternative work
12	site does not affect whether a day is considered a business day
13	under this chapter.
14	(c) An optional holiday under Section 662.003(c) is not a
15	business day of a governmental body if the officer for public
16	information of the governmental body observes the optional holiday.
17	(d) A holiday established by the governing body of an
18	institution of higher education under Section 662.011(a) is not a
19	business day of the institution of higher education.
20	(e) The Friday before or Monday after a holiday described by
21	Subsection (a)(2) or (3) is not a business day of a governmental
22	body if the holiday occurs on a Saturday or Sunday and the
23	governmental body observes the holiday on that Friday or Monday.
24	(f) Subject to the requirements of this subsection, a

governmental body may designate a day on which the governmental 1 body's administrative offices are closed or operating with minimum 2 staffing as a nonbusiness day. The designation of a nonbusiness day 3 for an independent school district must be made by the board of 4 5 trustees. The designation of a nonbusiness day for a governmental body other than an independent school district must be made by the 6 executive director or other chief administrative officer. A 7 8 governmental body may designate not more than 10 nonbusiness days under this subsection each calendar year. A governmental body 9 shall make a good faith effort to post advance notice of the 10 nonbusiness days designated under this subsection on the 11 12 governmental body's Internet website. SECTION 2. Section 552.261, Government Code, is amended by 13 14 adding Subsection (f) to read as follows: 15 (f) A governmental body may not impose a charge under this subchapter for providing a copy of public information if the 16 17 information is a report required to be filed with the governmental

18 body under Subchapter C or D, Chapter 254, Election Code, unless all 19 of those reports filed with the governmental body during the 20 preceding year are available to the public on the governmental 21 body's Internet website.

22 SECTION 3. Section 552.301(b), Government Code, is amended 23 to read as follows:

(b) The governmental body must ask for the attorney general's decision and state the <u>specific</u> exceptions that apply within a reasonable time but not later than the 10th business day after the date of receiving the written request.

(a) If a governmental body fails to respond to a requestor as required by 7 8 Section 552.221, the requestor may send a written complaint to the attorney general. 9 10 (b) The complaint must include: (1) the original request for information; and 11 12 (2) any correspondence received from the governmental 13 body in response to the request. 14 (c) If the attorney general determines the governmental 15 body improperly failed to comply with Section 552.221 in connection with a request for which a complaint is made under this section: 16 17 (1) the attorney general shall notify the governmental body in writing and require the governmental body to complete open 18 19 records training not later than six months after receiving the notification; 20 21 (2) the governmental body may not assess costs to the requestor for producing information in response to the request; and 22 (3) if the governmental body seeks to withhold 23 24 information in response to the request, the governmental body must: 25 (A) request an attorney general decision under 26 Section 552.301 not later than the fifth business day after the date the governmental body receives the notification under Subdivision 27

2	(B) release the requested information unless
3	there is a compelling reason to withhold the information.
4	SECTION 6. The changes in law made by this Act apply only to
5	a request for information that is received by a governmental body or
6	an officer for public information on or after the effective date of
7	this Act.
8	SECTION 7. This Act takes effect September 1, 2023.
