- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 1103.004, Occupations Code, is amended
- 6 to read as follows:
- 7 Sec. 1103.004. APPLICABILITY OF CHAPTER. (a) This chapter
- 8 does not apply to:
- 9 (1) a person who is authorized by law to perform an
- 10 evaluation of real property for or to provide an evaluation of real
- 11 property to another person;
- 12 (2) a real estate broker licensed under Chapter 1101
- 13 or a sales agent acting under the authority of a sponsoring broker
- 14 who provides to another person a written analysis, opinion, or
- 15 conclusion relating to the estimated price of real property if the
- 16 analysis, opinion, or conclusion:
- 17 (A) is not referred to as an appraisal;
- 18 (B) is given in the ordinary course of the
- 19 broker's business; and
- (C) is related to the actual or potential
- 21 acquisition, disposition, encumbrance, or management of an
- 22 interest in real property;
- 23 (3) an appraiser certified by a jurisdiction other
- 24 than this state who performs an appraisal review of an appraisal

- 1 performed on real property in this state, if the appraiser does not
- 2 offer an opinion of value as part of the appraisal review;
- 3 (4) an employee of a federally regulated financial
- 4 institution or any other person engaged by the institution who
- 5 performs an evaluation of real property for use by the institution
- 6 in a transaction for which the institution is not required to use
- 7 the services of a licensed or certified appraiser under federal
- 8 regulations adopted under Title XI, Financial Institutions Reform,
- 9 Recovery, and Enforcement Act of 1989 (12 U.S.C. Section 1833e) or
- 10 under applicable state law;
- 11 (5) an employee of a non-bank financial institution or
- 12 any other person engaged by the institution who provides an
- 13 analysis, assessment, opinion, conclusion, notation, or
- 14 compilation of data concerning the value of an interest in real
- 15 property for use by the institution; [ex]
- 16 (6) the procurement or use of an automated valuation
- 17 model; or
- 18 (7) a person who:
- 19 (A) performs appraisals in connection with the
- 20 Practical Applications of Real Estate Appraisal course as approved
- 21 by the Appraiser Qualifications Board; and
- (B) does not use a title or a reference in
- 23 violation of Section 1103.201(b).
- (b) Notwithstanding Subsection (a)(7), the appraisals
- 25 described by that subsection may be credited by the board toward
- 26 satisfying the experience required to obtain a license or
- 27 certificate under this chapter.

- 2 amended to read as follows:
- 3 (c) For the purpose of determining the qualifications of an

- 8 [(2) experience as a real estate mortgage lending
- 9 officer of a financial institution or as a real estate broker that
- 10 includes the actual performance or technical review of real estate
- 11 appraisals].
- 12 SECTION 3. Section 1103.554(a), Occupations Code, is
- 13 amended to read as follows:
- 14 (a) A person commits an offense if the person knowingly [+

- 17 $[\frac{(2)}{2}]$ violates Section 1103.401.
- SECTION 4. Subchapter E, Chapter 1104, Occupations Code, is
- 19 amended by adding Section 1104.2051 to read as follows:
- Sec. 1104.2051. INVESTIGATIVE COMMITTEE. (a) The
- 21 presiding officer of the board, with the advice and consent of the
- 22 executive committee of the board, may appoint an investigative
- 23 committee.
- 24 (b) An investigative committee consists of at least two
- 25 members. The presiding officer of the investigative committee must
- 26 be a board member.

- 3 regarding the complaint to the board.
- 4 SECTION 5. The following provisions of the Occupations Code
- 5 are repealed:
- 6 (1) Section 1103.205(b); and
- 7 (2) Section 1103.259.
- 8 SECTION 6. The changes in law made by this Act to Section
- 9 1103.205, Occupations Code, apply only to an application for a
- 10 certificate or license submitted to the Texas Appraiser Licensing
- 11 and Certification Board on or after the effective date of this Act.
- 12 An application submitted before the effective date of this Act is
- 13 governed by the law in effect on the date the application was
- 14 submitted, and the former law is continued in effect for that
- 15 purpose.
- 16 SECTION 7. The change in law made by this Act to Section
- 17 1103.554, Occupations Code, applies only to an offense committed on
- 18 or after the effective date of this Act. An offense committed
- 19 before the effective date of this Act is governed by the law in
- 20 effect on the date the offense was committed, and the former law is
- 21 continued in effect for that purpose. For purposes of this section,
- 22 an offense was committed before the effective date of this Act if
- 23 any element of the offense occurred before that date.
- SECTION 8. The changes in law made by this Act by the
- 25 enactment of Section 1104.2051, Occupations Code, apply only to a
- 26 complaint submitted to the Texas Appraiser Licensing and
- 27 Certification Board on or after the effective date of this Act. A

- 1 complaint submitted before the effective date of this Act is
- 2 governed by the law in effect on the date the complaint was
- 3 submitted, and the former law is continued in effect for that
- 4 purpose.
- 5 SECTION 9. This Act takes effect September 1, 2023.
