4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 272.0001, Business & Commerce Code, is 6 amended to read as follows:

7 Sec. 272.0001. <u>DEFINITIONS</u> [DEFINITION]. In this chapter:

(1) "Construction[<del>,"construction</del>] contract" means a 8 9 contract, subcontract, or agreement entered into or made by an owner, architect, engineer, contractor, construction manager, 10 subcontractor, supplier, or material or equipment lessor for the 11 12 design, construction, alteration, removation, remodeling, or repair of, or for the furnishing of material or equipment for, a 13 building, structure, appurtenance, or other improvement to or on 14 public or private real property, including moving, demolition, and 15 16 excavation connected with the real property. The term includes an 17 agreement to which an architect, engineer, or contractor and an owner's lender are parties regarding an assignment of the 18 construction contract or other modifications thereto. 19

20 <u>(2) "Copy" means an accurate reproduction of an</u> 21 <u>original document reproduced in paper form or in an electronic</u> 22 <u>format that a person can access, download, save, and print for the</u> 23 <u>person's own records.</u>

(3) "Original contract" means an agreement to which an

1	owner is a party either directly or by implication of law.
2	(4) "Original contractor" means a person contracting
3	with an owner directly or through the owner's agent.
4	(5) "Owner" means a person who owns any interest in
5	real property or an authorized agent, trustee, or receiver of the
6	person.
7	(6) "Subcontractor" means a person who furnishes labor
8	or materials to fulfill an obligation to an original contractor or
9	to a subcontractor of any tier to perform all or part of the work
10	required by an original contract.
11	SECTION 2. The heading to Section 272.001, Business &

14	SECTION 3. Section 272.001, Business & Commerce Code, is
15	amended by adding Subsections (c), (d), (e), (f), (g), and (h) to

17	(c) Except as provided by Subsection (g), a provision in a
18	construction contract between an original contractor and owner that
19	incorporates another document that contains terms and conditions,
20	by reference or otherwise, is voidable by the original contractor
21	if, on written request, the owner does not provide a copy of the
22	incorporated document to the original contractor on or before the
23	10th day before the date the contract is executed. This subsection
24	does not preclude the owner from redacting information from a
25	document to be incorporated into the contract, provided that any
26	redacted information may not be incorporated into the contract by
27	reference or otherwise. The owner may request the original

2 statement acknowledging receipt of the copy of the incorporated document. The written statement acknowledging receipt must be 3 provided separately from the construction contract. 4 5 (d) Except as provided by Subsection (g), a provision in a construction contract between a subcontractor and an original 6 7 contractor that incorporates another document that contains terms and conditions, by reference or otherwise, is voidable by the 8 subcontractor if, on written request, the original contractor does 9 not provide a copy of the incorporated document to the 10 subcontractor on or before the 10th day before the date the contract 11 12 is executed. This subsection does not preclude the original contractor from redacting information from a document to be 13 incorporated into the contract, provided that any redacted 14 15 information may not be incorporated into the contract by reference or otherwise. The original contractor may request the 16 17 subcontractor to sign, date, and submit to the original contractor a written statement acknowledging receipt of the copy of the 18 19 incorporated document. The written statement acknowledging receipt must be provided separately from the construction contract. 20 21 (e) Except as provided by Subsection (g), a provision in a construction contract between a subcontractor and another 22 subcontractor that incorporates another document that contains 23 24 terms and conditions, by reference or otherwise, is voidable by the subcontractor who is to furnish labor or materials to fulfill an 25 26 obligation to the other subcontractor if, on written request, the subcontractor to whom the requesting subcontractor is obligated 27

does not provide a copy of the incorporated document to the 1 requesting subcontractor on or before the 10th day before the date 2 the contract is executed. This subsection does not preclude a 3 subcontractor from redacting information from a document to be 4 5 incorporated into the contract, provided that any redacted information may not be incorporated into the contract by reference 6 7 or otherwise. The subcontractor providing the copy of the document 8 may request the other subcontractor to sign, date, and submit a written statement acknowledging receipt of the copy of the 9 incorporated document. The written statement acknowledging 10 receipt must be provided separately from the construction contract. 11 12 (f) A provision in a construction contract made void by a party to the contract under Subsection (c), (d), or (e) is void only 13 14 to the extent of the provision's applicability to the incorporated 15 document or a portion of the incorporated document that was not 16 provided to the party. 17 (g) Subsections (c), (d), and (e) do not apply to the incorporation of a publicly available document. 18 19 (h) An owner, original contractor, or subcontractor may

provide a copy of an incorporated document to the other party to a 20 construction contract under Subsection (c), (d), or (e) by 21 providing a link to the document on an Internet website or file 22 hosting service that may be accessed by the other party free of 23 24 charge for the duration of the term of the contract. The version of the incorporated document that is accessible on the date the party 25 26 receives the information necessary to access the document is the version of the document that is incorporated into the contract. 27

SECTION 4. Chapter 272, Business & Commerce Code, is
amended by adding Section 272.003 to read as follows:

3 <u>Sec. 272.003. WAIVER OF CHAPTER PROHIBITED.</u> A person may 4 <u>not waive this chapter, including a provision of this chapter, by</u> 5 <u>contract or other means. A purported waiver of this chapter is void</u> 6 <u>as against public policy.</u>

SECTION 5. The changes in law made by this Act apply only to a contract that is entered into or renewed on or after the effective date of this Act.
