- 3 SECTION 2. Chapter 14, Alcoholic Beverage Code, is amended
- 4 by adding Section 14.09 to read as follows:
- 5 Sec. 14.09. SALES AT TEMPORARY LOCATION. (a) The holder of
- 6 <u>a distiller's and rectifier's permit may sell distilled spirits at a</u>
- 7 civic or distilled spirits festival, farmers' market, celebration,
- 8 or similar event promoting culture and tourism in this state.
- 9 (b) The holder of a distiller's and rectifier's permit may
- 10 not offer distilled spirits for sale under this section on more than
- 11 four consecutive days at the same location.
- 12 <u>(c) The commission shall adopt rules to implement this</u>
- 13 <u>section</u>, including rules that:
- 14 (1) require the permit holder to notify the commission
- 15 of the dates on which and location where the permit holder will
- 16 temporarily offer distilled spirits for sale under this section;
- 17 (2) establish a procedure to verify the wet or dry

- 4 SECTION 3. This Act takes effect September 1, 2023.
