firearm to any person who has been convicted of a felony before the fifth anniversary of the later of the following dates: (A) the person's release from confinement following conviction of the felony; or (B) the person's release from supervision under community supervision, parole, or mandatory supervision following conviction of the felony; (5) sells, rents, leases, loans, or gives a handgun to any person knowing that an active protective order is directed to the person to whom the handgun is to be delivered; (6) knowingly purchases, rents, leases, or receives as a loan or gift from another a handgun while an active protective order is directed to the actor; or (7) while prohibited from possessing a firearm under state or federal law, knowingly makes a material false statement on a form that is: (A) required by state or federal law for the purchase, sale, or other transfer of a firearm; and submitted to a [licensed] firearms dealer (B) licensed under [, as defined by] 18 U.S.C. Section 923. It is an affirmative defense to prosecution under (c) Subsection (a)(2)(A) [(a)(2)] that the transfer was to a minor whose parent or the person having legal custody of the minor had given written permission for the sale or, if the transfer was other than a sale, the parent or person having legal custody had given

(a)(2)(B) that the recipient of a transfer of a firearm is: 1 2 (A) a peace officer; or 3 (B) a member of the United States armed forces; 4 or 5 (C) has been honorably discharged from the United 6 States Armed forces. 7 An offense under this section is a Class A misdemeanor, (d) 8 except that: 9 (1)an offense under Subsection (a)(2)(A) [(a)(2)] is 10 a state jail felony if the weapon that is the subject of the offense 11 is a handgun; and 12 (2) an offense under Subsection (a)(2)(B) or (a)(7) is a state jail felony. 13 SECTION 2. The change in law made by this Act applies only 14 15 to an offense committed on or after the effective date of this Act. An offense committed before the effective date of this Act is 16 17 governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. 18 For purposes of this section, an offense was committed before the 19 effective date of this Act if any element of the offense occurred 20 before that date. 21 SECTION 3. To the extent of any conflict, this Act prevails 22 over another Act of the 88th Legislature, Regular Session, 2023, 23 24 relating to nonsubstantive additions to and corrections in enacted 25 codes.

26 SECTION 4. This Act takes effect September 1, 2023.
