A BILL TO BE ENTITLED AN ACT

relating to requirements related to refunds and credit provided under terminated debt cancellation agreements. 1-22 1**-**23 1-24

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 354.007, Finance Code, is amended by amending Subsections (e), (f), and (g) and adding Subsection (e-1) 1-25 1-26 1-27 1-28 to read as follows:

If the debt cancellation agreement terminates due to the (e) early termination of the contract, <u>a [the]</u> holder who is a retail 1-29 seller who has not assigned or transferred the contract shall: 1-30

(1) $[\tau]$ not later than the 60th day after the date the 1-31 1-32 debt cancellation agreement terminates [+
