SECTION 2. Section 44.0041, Education Code, is amended to 3 read as follows: 4

Sec. 44.0051. POSTING OF ADOPTED BUDGET. On final 5 (a) approval of the budget by the board of trustees, the school district 6 shall post on the district's Internet website a copy of the budget, 7 8 in line-item form, adopted by the board of trustees. The district's Internet website must prominently display the electronic link to 9 the adopted budget, in line-item form. 10

The district shall maintain the adopted budget, in 11 (b) line-item form, on the district's Internet website until the third 12 anniversary of the date the budget was adopted. 13

14 SECTION 3. Section 102.005, Local Government Code, is 15 amended to read as follows:

Sec. 102.005. PROPOSED BUDGET FILED WITH MUNICIPAL CLERK; 16 17 PUBLIC INSPECTION. (a) The budget officer shall file the proposed budget with the municipal clerk before the 30th day before the date 18 the governing body of the municipality makes its tax levy for the 19 fiscal year. 20

21 (b) A proposed budget that will require raising more revenue from property taxes than in the previous year must contain a cover 22 23 page with the following statement in 18-point or larger type: "This 24 budget will raise more total property taxes than last year's budget by (insert total dollar amount of increase and percentage 25 26 increase), and of that amount (insert amount computed by multiplying the proposed tax rate by the value of new property added 27

1 to the roll) is tax revenue to be raised from new property added to 2 the tax roll this year."

3 (c) The proposed budget<u>, in line-item form</u>, shall be 4 available for inspection by any person. If the municipality 5 maintains an Internet website, the municipal clerk shall take 6 action to ensure that the proposed budget<u>, in line-item form</u>, is 7 posted on the website.

8 SECTION 4. Section 102.008, Local Government Code, is 9 amended to read as follows:

Sec. 102.008. APPROVED BUDGET FILED WITH MUNICIPAL CLERK:
POSTING ON INTERNET. (a) On final approval of the budget by the
governing body of the municipality, the governing body shall:

13 (1) file the budget with the municipal clerk; and

14 (2) if the municipality maintains an Internet website,15 take action to ensure that:

16 (A) a copy of the budget, <u>in line-item form</u>,
17 including the cover page, is posted on the website; and

(B) the record vote described by Section
102.007(d)(2) is posted on the website at least until the first
anniversary of the date the budget is adopted.
