## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the creation of a universal higher education savings
- 3 trust account by the Prepaid Higher Education Tuition Board.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 54.701(10), Education Code, is amended 6 to read as follows:
- 7 (10) "Savings trust account" means an account
- 8 established through the plan by an individual or the board under
- 9 this subchapter on behalf of a beneficiary in order to apply
- 10 distributions from the account toward qualified higher education
- 11 expenses at eligible educational institutions.
- 12 SECTION 2. Subchapter G, Chapter 54, Education Code, is
- 13 amended by adding Section 54.7071 to read as follows:
- 14 Sec. 54.7071. UNIVERSAL SAVINGS TRUST ACCOUNT. (a) From
- 15 money available for the purpose, the board shall open a universal
- 16 savings trust account to save money for the payment of the qualified
- 17 higher education expenses of each child born in this state.
- (b) For purposes of this subchapter, the board is the owner
- 19 of the universal savings trust account. Except as provided by
- 20 Subsection (d), each child born in this state on or after September
- 21 1, 2023, is a beneficiary of the account.
- (c) Except as provided by Subsection (d), on receipt of
- 23 notice regarding the birth of a child in this state from the
- 24 Department of State Health Services under Section 191.011, Health

- 1 and Safety Code, the board shall deposit \$100 in the universal
- 2 savings trust account on behalf of the child.
- 3 (d) The parent or legal guardian of a child born in this
- 4 state may opt out of the contribution to the universal savings trust
- 5 account on the child's behalf under Subsection (c) by submitting a
- 6 written request to the board.
- 7 (e) The board shall distribute money in the universal
- 8 savings trust account to a beneficiary of the account in accordance
- 9 with board rule.
- 10 (f) The board shall develop and implement an outreach
- 11 program to inform parents and legal guardians of children born in
- 12 this state regarding the universal savings trust account and the
- 13 right to opt out of the contribution to the account under Subsection
- 14 (d).
- SECTION 3. Section 54.709(d), Education Code, is amended to
- 16 read as follows:
- 17 (d) A savings trust agreement must provide that, if after a
- 18 specified period the savings trust agreement has not been
- 19 terminated and the beneficiary's rights in the account have not
- 20 been exercised, the board, after making reasonable efforts to
- 21 contact the owner and beneficiary of the account or their agents,
- 22 shall:
- 23 <u>(1)</u> report the unclaimed money in the account to the
- 24 comptroller; or
- 25 (2) if the account is the universal savings trust
- 26 <u>account opened under Section 54.7071</u>, withdraw from the account the
- 27 money attributable to the beneficiary and deposit the money in the

- 1 general revenue fund.
- 2 SECTION 4. Subchapter A, Chapter 191, Health and Safety
- 3 Code, is amended by adding Section 191.011 to read as follows:
- 4 Sec. 191.011. BIRTH INFORMATION FOR PREPAID HIGHER
- 5 EDUCATION TUITION BOARD. (a) The department shall implement an
- 6 efficient and effective method to inform the Prepaid Higher
- 7 Education Tuition Board regarding the birth of a child in this state
- 8 as necessary for the board to administer the universal savings
- 9 trust account under Section 54.7071, Education Code.
- 10 (b) The department shall enter into a memorandum of
- 11 understanding with the Prepaid Higher Education Tuition Board to
- 12 <u>implement this section</u>.
- SECTION 5. This Act takes effect September 1, 2023.
