Section 31.002, Civil Practice and Remedies 4 5 Code, is amended by amending Subsection (f) and adding Subsections (i) and (j) to read as follows: 6 (f) A court may not enter or enforce an order under this 7 section that requires the turnover of <u>a paycheck or</u> the <u>sales</u> 8 9 proceeds of, or the disbursement of, property exempt under any statute, including Section 42.0021, Property Code. This subsection 10 does not apply to the enforcement of a child support obligation or a 11 judgment for past due child support. 12 (i) If a final money judgment remains unsatisfied in justice 13 14 court for longer than six months, a judgment creditor is entitled to a hearing on the judgment creditor's motion for the court's 15 assistance under this section. If notice of the hearing is provided 16 to the judgment debtor, the court shall appoint a receiver under 17 Subsection (b)(3) to enforce the judgment unless the judgment 18 debtor appears and contests the appointment. 19 (j) A court may issue an order under this section that 20 requires the turnover of all nonexempt property of the judgment 21 debtor without requiring the judgment creditor to prove the 22

23 existence of specific property owned by the judgment debtor.

3 SECTION 3. This Act takes effect September 1, 2023.
