- 14 SECTION 2. ASSESSMENT; WORKGROUP. (a) The council shall
- 15 establish and oversee a workgroup to assess the feasibility of
- 16 using surplus government property to provide housing to homeless
- 17 veterans.
- 18 (b) The workgroup is composed of the executive head of each
- 19 of the following state agencies or that person's designee:
- 20 (1) the Texas Veterans Commission;
- 21 (2) the General Land Office;
- 22 (3) the Veterans' Land Board; and
- 23 (4) the Texas Department of Housing and Community
- 24 Affairs.
