## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the authority of certain counties to impose a county hotel occupancy tax. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 352.002(a), Tax Code, is amended to read as follows: 6 7 (a) The commissioners courts of the following counties by the adoption of an order or resolution may impose a tax on a person 8 9 who, under a lease, concession, permit, right of access, license, contract, or agreement, pays for the use or possession or for the 10 right to the use or possession of a room that is in a hotel, costs \$2 11 12 or more each day, and is ordinarily used for sleeping: 13 (1) a county that has a population of more than 3.3 14 million; a county that has a population of 90,000 or more, (2) 15 borders the United Mexican States, does not border the Gulf of 16 Mexico, and does not have four or more cities that each have a 17 population of more than 25,000; 18 (3) a county in which there is no municipality; 19 20 (4) a county in which there is located an Indian reservation under the jurisdiction of the United States government; 21 22 (5) a county that has a population of 30,000 or less, 23 that has no more than one municipality with a population of less than 2,500, and that borders two counties located wholly in the 24

5 SECTION 2. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2023.
