- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Subchapter A, Chapter 46B, Code of Criminal
- 8 Procedure, is amended by adding Article 46B.014 to read as follows:
- 9 Art. 46B.014. TRANSFER TO COMMISSION; COMPENSATION TO
- 10 COUNTIES. (a) The commission shall take custody of a defendant
- 11 awaiting transfer under an order issued under Article 46B.073 to a
- 12 facility operated by or under contract with the commission, not
- 13 <u>later than the 45th day following the date the order is issued.</u>
- 14 (b) If the commission does not take custody of a defendant
- 15 within the period prescribed by Subsection (a), the commission
- 16 shall compensate the county for the cost of confinement for each day
- 17 that the defendant remains confined in the county jail following
- 18 the expiration of that period. The compensation must be equal to
- 19 the amount that would have been incurred by the commission to
- 20 confine the defendant for that period.
- 21 SECTION 2. Section 54.04, Family Code, is amended by adding
- 22 Subsections (s) and (t) to read as follows:
- 23 (s) If the judge orders a disposition under this section
- 24 sentencing a child to commitment in the Texas Juvenile Justice

- 1 Department, the department shall accept custody of the child not
- 2 later than the 45th day after the date on which the judge signs the
- 3 disposition order committing the child to the department.
- 4 (t) If the Texas Juvenile Justice Department does not take
- 5 custody of a child within the period prescribed by Subsection (s),
- 6 the department shall compensate the county for the cost of
- 7 detention for each day that the child remains detained in a facility
- 8 operated by or under contract with the county following the
- 9 expiration of that period. The compensation must be equal to the
- 10 amount that would have been incurred by the department to detain the
- 11 child for that period.
- 12 SECTION 3. Section 499.071, Government Code, is amended to
- 13 read as follows:
- 14 Sec. 499.071. SCHEDULED ADMISSIONS POLICY. The board shall
- 15 adopt and enforce a scheduled admissions policy that <u>requires</u>
- 16 [permits] the department [institutional division] to accept
- 17 <u>persons</u> [inmates] within 45 days of processing as required by
- 18 Section 499.1215 [499.121(c)].
- 19 SECTION 4. Subchapter F, Chapter 499, Government Code, is
- 20 amended by adding Section 499.1215 to read as follows:
- 21 Sec. 499.1215. TRANSFER TO DEPARTMENT; COMPENSATION TO
- 22 COUNTIES. (a) The department shall take custody of a person
- 23 awaiting transfer to the department following conviction of a
- 24 felony not later than the 45th day following the date on which all
- 25 processing required for transfer has been completed.
- 26 (b) If the department does not take custody of a person
- 27 within the period prescribed by Subsection (a), the department

- 1 shall compensate the county for the cost of confinement for each day
- 2 that the person remains confined in the county jail following the
- 3 <u>expiration of that period</u>. The compensation must be equal to the
- 4 amount that would have been incurred by the department to confine
- 5 the person for that period.
- 6 (c) If a person remains confined in the county jail
- 7 following the expiration of the period prescribed by Subsection (a)
- 8 due to a delay caused by the county:
- 9 (1) the county is not entitled to compensation under
- 10 Subsection (b) for any day that the person remains confined due to
- 11 the delay caused by the county; and
- 12 (2) the county and the department shall arrange to
- 13 transfer the person to the department as soon as practicable after
- 14 the delay.
- SECTION 5. Subchapter I, Chapter 508, Government Code, is
- 16 amended by adding Section 508.285 to read as follows:
- 17 Sec. 508.285. TRANSFER TO DEPARTMENT; COMPENSATION TO
- 18 COUNTIES. (a) The department shall take custody of a releasee or
- 19 person described by Section 508.281(a) who is confined only on a
- 20 charge that the releasee or person has committed an administrative
- 21 violation of release not later than the 45th day after the date on
- 22 which all processing required for transfer has been completed.
- 23 (b) If the department does not take custody of a person
- 24 within the period prescribed by Subsection (a), the department
- 25 shall compensate the county for the cost of confinement for each day
- 26 that the person remains confined in the county jail following the
- 27 expiration of that period. The compensation must be equal to the

- 1 amount that would have been incurred by the department to confine
- 2 the person for that period.
- 3 SECTION 6. Section 499.121(c), Government Code, is
- 4 repealed.
- 5 SECTION 7. Not later than December 31, 2023, the Texas Board
- 6 of Criminal Justice shall adopt the scheduled admissions policy
- 7 required by Section 499.071, Government Code, as amended by this
- 8 Act.
- 9 SECTION 8. (a) Article 46B.014, Code of Criminal
- 10 Procedure, as added by this Act, applies only to compensation to a
- 11 county for the cost of a defendant's confinement that occurs on or
- 12 after January 1, 2024, regardless of whether the order of
- 13 commitment is issued before, on, or after that date.
- 14 (b) Section 54.04, Family Code, as amended by this Act,
- 15 applies only to compensation to a county for the cost of a child's
- 16 detention that occurs on or after January 1, 2024, regardless of
- 17 whether the disposition order is issued before, on, or after that
- 18 date.
- 19 (c) Sections 499.1215 and 508.285, Government Code, as
- 20 added by this Act, apply only to compensation to a county for the
- 21 cost of confinement of a person that occurs on or after January 1,
- 22 2024, regardless of whether all processing required for transfer of
- 23 the person to the Texas Department of Criminal Justice is completed
- 24 before, on, or after that date.
- 25 SECTION 9. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this

- 1 Act does not receive the vote necessary for immediate effect, this
- 2 Act takes effect September 1, 2023.
