## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to adding a designation on a person's driver's license or
- 3 commercial driver's license indicating that the person is licensed
- 4 to carry a handgun.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 507.001(b), Business & Commerce Code, is
- 7 amended to read as follows:
- 8 (b) This section does not affect:
- 9 (1) the requirement to display a handgun license under
- 10 Section 411.205, Government Code[, that a person subject to that
- 11 section present a driver's license or identification certificate in
- 12 addition to a concealed handgun license]; or
- 13 (2) the types of identification required under federal
- 14 law to access airport premises or pass through airport security.
- 15 SECTION 2. Subchapter H, Chapter 411, Government Code, is
- 16 amended by adding Section 411.1795 to read as follows:
- 17 Sec. 411.1795. DESIGNATION ON DRIVER'S LICENSE OR
- 18 COMMERCIAL DRIVER'S LICENSE. The department shall adopt rules
- 19 allowing an applicant for an original, duplicate, modified, or
- 20 renewed license under this subchapter, in addition to being issued
- 21 an original, duplicate, modified, or renewed license, to elect to
- 22 include on the person's driver's license or commercial driver's
- 23 license a designation indicating that the person is licensed under
- 24 this subchapter. The rules must include procedures to ensure that a

- 1 person who makes an election under this section:
- 2 (1) receives a designation on the person's driver's
- 3 license or commercial driver's license only if the person meets the
- 4 requirements for issuance of the original, duplicate, modified, or
- 5 renewed handgun license; and
- 6 (2) maintains the designation only during the period
- 7 for which the person is licensed to carry a handgun under this
- 8 subchapter.
- 9 SECTION 3. Section 411.205, Government Code, is amended to
- 10 read as follows:
- 11 Sec. 411.205. REQUIREMENT TO DISPLAY LICENSE. If a license
- 12 holder is carrying a handgun on or about the license holder's person
- 13 when a magistrate or a peace officer demands that the license holder
- 14 display identification, the license holder shall display:
- 15 (1) either of the following:
- 16 (A) the license holder's driver's license or
- 17 commercial driver's license that includes a handgun license
- 18 designation under Section 521.128 or 522.030, Transportation Code;
- 19 or
- 20 (B) both the license holder's driver's license,
- 21 commercial driver's license, or personal identification
- 22 certificate issued by the department and the license holder's
- 23 handgun license; and
- 24 (2) if the license holder's handgun license bears a
- 25 protective order designation, a copy of the applicable court order
- 26 under which the license holder is protected.
- 27 SECTION 4. Subchapter F, Chapter 521, Transportation Code,

- 1 is amended by adding Section 521.128 to read as follows:
- 2 Sec. 521.128. HANDGUN LICENSE DESIGNATION. The department
- 3 shall include on each driver's license issued to a person licensed
- 4 to carry a handgun under Subchapter H, Chapter 411, Government
- 5 Code, who makes an election under Section 411.1795, Government
- 6 Code, a designation that shows the person is licensed under that
- 7 subchapter. The designation must include the person's handgun
- 8 license number and a statement of the period for which the handgun
- 9 license is effective.
- SECTION 5. Section 522.030, Transportation Code, is amended
- 11 by adding Subsection (e) to read as follows:
- 12 (e) The department shall include on each commercial
- 13 driver's license issued to a person licensed to carry a handgun
- 14 under Subchapter H, Chapter 411, Government Code, who makes an
- 15 <u>election under Section 411.1795</u>, <u>Government Code</u>, a <u>designation</u>
- 16 that shows the person is licensed under that subchapter. The
- 17 designation must include the person's handgun license number and a
- 18 statement of the period for which the handgun license is effective.
- 19 SECTION 6. Not later than December 1, 2023, the Department
- 20 of Public Safety shall adopt the rules required by Section
- 21 411.1795, Government Code, as added by this Act.
- SECTION 7. (a) Section 411.1795, Government Code, as added
- 23 by this Act, applies only to an applicant for an original,
- 24 duplicate, modified, or renewed license to carry a handgun under
- 25 Subchapter H, Chapter 411, Government Code, as amended by this Act,
- 26 who submits the application on or after January 1, 2024.
- 27 (b) The changes in law made by this Act to Chapters 521 and

- 1 522, Transportation Code, apply only to a driver's license or
- 2 commercial driver's license issued or renewed under Chapter 521 or
- 3 522, Transportation Code, on or after January 1, 2024.
- 4 SECTION 8. This Act takes effect September 1, 2023.
