BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-22 1-23 SECTION 1. Section 507.001(b), Business & Commerce Code, is 1-24 amended to read as follows: 1-25

This section does not affect:

1-26 the requirement to display a handgun license under (1)Section 411.205, Government Code[, that a person subject to that section present a driver's license or identification certificate in 1-27 1-28 addition to a concealed handgun license]; or 1-29

1-30 (2) the types of identification required under federal 1-31 law to access airport premises or pass through airport security.

1-32 SECTION 2. Subchapter H, Chapter 411, Government Code, is amended by adding Section 411.1795 to read as follows: 1-33
