- 10 (2) the present value of the total amount of health
- 11 insurance and dental insurance premiums payable for the benefit of
- 12 the child from the month in which the obligor dies until the month
- 13 in which the child turns 18 years of age, based on the cost of health
- 14 insurance and dental insurance for the child ordered to be paid on
- 15 the date of the obligor's death;
- 16 (3) in the case of [a disabled child under 18 years of
- 17 age or an adult with a medically determinable disability
- 18 [disabled child], an amount to be determined by the court under
- 19 Section 154.306;
- 20 (4) the nature and amount of any benefit to which the
- 21 child would be entitled as a result of the obligor's death,
- 22 including life insurance proceeds, annuity payments, trust
- 23 distributions, social security death benefits, and retirement
- 24 survivor benefits; and
- 25 (5) any other financial resource available for the
- 26 support of the child.
- SECTION 6. Section 154.016(b), Family Code, is amended to

- 2 (b) In determining the nature and extent of the obligation
- 3 to provide for the support of the child in the event of the death of
- 4 the obligor, the court shall consider all relevant factors,
- 5 including:
- 6 (1) the present value of the total amount of monthly
- 7 periodic child support payments from the date the child support
- 8 order is rendered until the month in which the child turns 18 years
- 9 of age, based on the amount of the periodic monthly child support
- 10 payment under the child support order;
- 11 (2) the present value of the total amount of health
- 12 insurance and dental insurance premiums payable for the benefit of
- 13 the child from the date the child support order is rendered until
- 14 the month in which the child turns 18 years of age, based on the cost
- 15 of health insurance and dental insurance for the child ordered to be
- 16 paid; and
- 17 (3) in the case of [a disabled child under 18 years of
- 18 age or] an adult with a medically determinable disability
- 19 [disabled child], an amount to be determined by the court under

- 21 SECTION 7. The heading of Subchapter F, Chapter 154, Family

- 1 (1) "Adult [child]" means an individual [a child] 18
- 2 years of age or older.
- 3 (2) "Disability" means:
- 4 (A) the inability to engage in any substantial

- 6 or mental impairment that can be expected to result in death or that
- 7 has lasted or can be expected to last for a continuous period of not

- 11 <u>(i)</u> is unable to do work previously
- 12 performed by the adult; and

- 17 (3) "Personal supervision" means guidance and
- 18 instruction by someone who is physically present and in such
- 19 proximity that visual contact can be maintained and immediate
- 20 assistance given when required.
- 21 (4) "Substantial" means ample or sustaining ["Child"
- 22 means a son or daughter of any age].
- SECTION 9. Section 154.302, Family Code, is amended to read
- 24 as follows:
- Sec. 154.302. COURT-ORDERED FINANCIAL SUPPORT FOR ADULT
- 26 WITH MEDICALLY DETERMINABLE DISABILITY [DISABLED CHILD]. (a) The

- 1 (1) order either or both parents of an adult to provide
- 2 for the <u>financial</u> support of <u>the adult until the adult reaches 21</u>
- 3 <u>years of age or</u> [a child] for a [an indefinite] period of three
- 4 years if the adult is 21 years of age or older; and
- 5 (2) [may] determine the rights and duties of the
- 6 parents if the court identifies competent evidence in the record,
- 7 <u>including medical evidence</u>, and finds that:
- 8 (A) $\left[\frac{1}{1}\right]$ the adult:
- 9 (i) [child,] whether institutionalized or
- 10 not, has a medically determinable disability and requires
- 11 substantial care and personal supervision; [because of a mental or
- 12 physical disability] and
- 13 (ii) considering the adult's age,
- 14 education, skills, and work experience, cannot engage in any kind
- 15 of substantial gainful work [will not be capable of self-support];

- (B) $\left[\frac{(2)}{2}\right]$ the medically determinable disability

- 20 (a-1) A court must order a medical examination of the adult
- 21 or child under Rule 204, Texas Rules of Civil Procedure, before
- 22 making a finding of a medically determinable disability under
- 23 Subsection (a). The court shall order both parents to share the
- 24 cost of the medical examination equally.
- 25 (b) A court that orders financial support under this section
- 26 shall designate a parent of the adult [child] or another person
- 27 having physical custody or guardianship of the adult [child] under

- 1 a court order to receive the <u>financial</u> support for the <u>adult</u>
- 2 [child]. The court may designate an adult [a child who is 18 years
- 3 of age or older] to receive the financial support directly.
- 4 (c) Notwithstanding Subsection (b), a court that orders
- 5 financial support under this section for an adult [child] with a
- 6 <u>medically determinable</u> disability may designate a special needs
- 7 trust and provide that the financial support may be paid directly to
- 8 the trust for the benefit of the adult [child]. The court shall
- 9 order that financial support payable to a special needs trust under
- 10 this subsection be paid directly to the trust and may not order the
- 11 financial support be paid to the state disbursement unit. This
- 12 subsection does not apply in a Title IV-D case.
- 13 (d) An appeal of the final judgment is an accelerated appeal
- 14 and must be decided by a court of appeals not later than the 180th
- 15 day after the date a notice of appeal is filed.

- 7 support enforcement services under Section 159.307.
- 8 SECTION 11. Section 154.305, Family Code, is amended to
- 9 read as follows:
- 10 Sec. 154.305. SPECIFIC PROCEDURES. (a) A suit under this
- 11 subchapter may be filed:
- 12 (1) regardless of the age of the adult [child]; and
- 13 (2) as an independent cause of action or joined with
- 14 any other claim or remedy provided by this code.
- 15 (b) If no court has continuing, exclusive jurisdiction of
- 16 the adult [child], an action under this subchapter may be filed as
- 17 an original suit affecting the parent-child relationship.
- 18 (c) If there is a court of continuing, exclusive
- 19 jurisdiction, an action under this subchapter may be filed as a suit
- 20 for modification as provided by Chapter 156.
- 21 SECTION 12. Section 154.306, Family Code, is amended to
- 22 read as follows:
- Sec. 154.306. AMOUNT OF FINANCIAL SUPPORT FOR ADULT WITH
- 24 MEDICALLY DETERMINABLE DISABILITY [AFTER AGE 18]. In determining
- 25 the amount of financial support to be paid after an adult's [a
- 26 child's 18th birthday, the specific terms and conditions of that
- 27 financial support, and the rights and duties of both parents with

- 1 respect to the <u>financial</u> support of the <u>adult</u> [child], the court
- 2 shall determine and give special consideration to:
- 3 (1) any existing or future needs of the adult [child]
- 4 directly related to the adult's intellectual [adult child's mental]
- 5 or physical disability and the substantial care and personal
- 6 supervision directly required by or related to that disability;
- 7 (2) whether the parent pays for or will pay for the
- 8 care or supervision of the adult [child] or provides or will provide
- 9 substantial care or personal supervision of the adult [child];
- 10 (3) the financial resources available to both parents
- 11 for the support, care, and supervision of the adult [child]; and
- 12 (4) any other financial resources or other resources
- 13 or programs available for the support, care, and supervision of the
- 14 adult [child].
- 15 SECTION 13. Section 154.307, Family Code, is amended to
- 16 read as follows:
- 17 Sec. 154.307. MODIFICATION, TERMINATION, AND ENFORCEMENT.
- 18 (a) An order provided by this subchapter may contain provisions
- 19 governing the rights and duties of both parents with respect to the
- 20 <u>financial</u> support of the <u>adult</u> [child] and may be modified or
- 21 enforced in the same manner as any other order provided by this
- 22 title.
- 23 (b) Either parent may file a motion for termination of an
- 24 order for support for an indefinite period rendered under this
- 25 subchapter as it existed before September 1, 2023, if the adult who
- 26 is the subject of the order has attained a postsecondary education,

- 2 adult's own, does not receive continuous medical treatment for a
- 3 disability, or does not require substantial care and personal
- 4 supervision.
- 5 SECTION 14. Section 154.308, Family Code, is amended to
- 6 read as follows:
- 7 Sec. 154.308. REMEDY NOT EXCLUSIVE. (a) This subchapter
- 8 does not affect a parent's:
- 9 (1) cause of action for the support of an adult with a
- 10 medically determinable disability [a disabled child] under any
- 11 other law; or
- 12 (2) ability to contract for the support of an adult
- 13 with a medically determinable disability [a disabled child].
- 14 (b) This subchapter does not affect the substantive or
- 15 procedural rights or remedies of a person other than a parent,
- 16 including a governmental or private entity or agency, with respect
- 17 to the support of an adult with a medically determinable disability
- 18 [a disabled child] under any other law.
- 19 SECTION 15. Section 154.309, Family Code, is amended to
- 20 read as follows:
- Sec. 154.309. POSSESSION OF OR ACCESS TO ADULT <u>WITH</u>
- 22 MEDICALLY DETERMINABLE DISABILITY [DISABLED CHILD]. (a) A court
- 23 may render an order for the possession of or access to an adult with
- 24 <u>a medically determinable disability</u> [disabled child] that is
- 25 appropriate under the circumstances.
- 26 (b) Possession of or access to an adult described by
- 27 Subsection (a) [disabled child] is enforceable in the manner

- 1 provided by Chapter 157. An adult [disabled child] may refuse
- 2 possession or access if the adult [disabled child] is mentally
- 3 competent.
- 4 (c) A court that obtains continuing, exclusive jurisdiction
- 5 of a suit affecting the parent-child relationship involving an
- 6 adult with a medically determinable disability [a disabled person
- 7 who is a child] retains continuing, exclusive jurisdiction of
- 8 subsequent proceedings involving the person[, including
- 9 proceedings] after the person is an adult. Notwithstanding this
- 10 subsection and any other law, a probate court may exercise
- 11 jurisdiction in a guardianship proceeding for the person after the
- 12 person is an adult.
- SECTION 16. (a) The changes in law made by this Act apply to
- 14 a suit for the financial support of an adult with a medically
- 15 determinable disability filed on or after the effective date of
- 16 this Act. A suit filed before the effective date of this Act is
- 17 governed by the law in effect on the date the suit was filed, and the
- 18 former law is continued in effect for that purpose.
- 19 (b) The change in law made by this Act does not by itself
- 20 constitute a material and substantial change of circumstances under
- 21 Section 156.401, Family Code, sufficient to warrant modification of
- 22 a court order or a portion of a decree that provides for the
- 23 financial support of an adult with a medically determinable
- 24 disability rendered before the effective date of this Act.
- 25 SECTION 17. This Act takes effect September 1, 2023.
