## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the establishment and operation of an ammunition
- 3 facility by the Department of Public Safety.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 411, Government Code, is amended by
- 6 adding Subchapter S to read as follows:
- 7 SUBCHAPTER S. TEXAS AMMUNITION FACILITY
- 8 Sec. 411.551. DEFINITIONS. In this subchapter:
- 9 (1) "Ammunition" means a combination of projectiles,
- 10 cartridges, primers, and propellants designed to be discharged from
- 11 a firearm.
- 12 (2) "Facility" means the Texas ammunition facility
- 13 <u>established under this subchapter.</u>
- 14 (3) "Facility operator" means the person selected
- 15 under Section 411.552 to operate the facility.
- 16 (4) "Law enforcement officer" means a person who is a
- 17 peace officer under Article 2.12, Code of Criminal Procedure.
- 18 <u>(5) "Law enforcement officer trainee" means a person</u>
- 19 enrolled in the basic peace officer training course required for
- 20 the issuance of a peace officer license under Chapter 1701,
- 21 Occupations Code.
- 22 (6) "Quality ammunition" means ammunition that meets
- 23 the minimum safety specifications of the Sporting Arms and
- 24 Ammunition Manufacturers' Institute for the caliber and type of

- 1 cartridge manufactured, as specified.
- 2 Sec. 411.552. TEXAS AMMUNITION FACILITY. (a) The
- 3 department shall contract with a person to establish and operate a
- 4 facility that acquires, stores, and resells to law enforcement
- 5 agencies quality ammunition to ensure the availability of
- 6 ammunition for use by those agencies for training and public safety
- 7 with a preference for law enforcement officers and law enforcement
- 8 officer trainees.
- 9 (b) The department shall closely supervise the facility to
- 10 promote and ensure integrity, security, honesty, and fairness in
- 11 the operation of the facility.
- 12 Sec. 411.553. CERTAIN CONTRACT PROVISIONS REQUIRED. A
- 13 contract under this subchapter for the acquisition, storage, and
- 14 resale of quality ammunition must include provisions requiring:
- 15 (1) the ammunition to be manufactured in this state;
- 16 <u>and</u>
- 17 (2) the packaging for the ammunition to:
- (A) bear the state seal, state arms, or state
- 19 flag; and
- 20 (B) state "Made in Texas".
- Sec. 411.554. FACILITY OPERATOR POWERS AND DUTIES. (a) The
- 22 facility operator has the powers necessary to carry out the duties
- 23 imposed on the operator under a contract entered into under this
- 24 subchapter.
- 25 (b) The facility operator shall acquire and store quality
- 26 ammunition to be resold at a reasonable price only to law
- 27 enforcement agencies with a preference for use by law enforcement

- 1 officers and law enforcement officer trainees.
- 2 (c) The facility operator shall acquire and store
- 3 sufficient quality ammunition to prepare for potential future
- 4 shortages of ammunition from other sources.
- 5 Sec. 411.555. CERTAIN SALES PROHIBITED. The facility may
- 6 not sell ammunition or any component parts to any person except a
- 7 <u>law enforcement agency in this state.</u>
- 8 Sec. 411.556. DEDICATION OF REVENUE. Any proceeds
- 9 collected by the department under a contract awarded under this
- 10 subchapter shall be deposited in the general revenue fund to the
- 11 credit of the law enforcement officer standards and education fund
- 12 account and may be appropriated only for the purposes described by
- 13 this subchapter or Section 1701.157, Occupations Code.
- Sec. 411.557. ANNUAL REPORT. Not later than December 1 of
- 15 each year, the department shall submit a report to the governor and
- 16 the legislature on the condition, operation, and projected business
- 17 activity of the facility.
- SECTION 2. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2023.
