H.B. No. 3672

A BILL TO BE ENTITLED

AN ACT

relating to the designation of portions of the state highway system as memorial highways for certain deceased peace officers.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter B, Chapter 225, Transportation Code, is amended by adding Sections 225.217, 225.218, 225.219, 225.220, 225.221, and 225.222 to read as follows:

Sec. 225.217. TROOPER RUSSELL LYNN BOYD MEMORIAL HIGHWAY.

(a) The portion of State Highway 159 in the municipal limits of Hempstead is designated as the Trooper Russell Lynn Boyd Memorial Highway.

(b) Subject to Section 225.021(c), the department shall:

(1) design and construct markers indicating the designation as the Trooper Russell Lynn Boyd Memorial Highway and any other appropriate information; and

(2) erect a marker at each end of the highway and at appropriate intermediate sites along the highway.

Sec. 225.218. RANGER STANLEY K. GUFFEY MEMORIAL HIGHWAY.

(a) The portion of U.S. Highway 87 in the municipal limits of Brady is designated as the Ranger Stanley K. Guffey Memorial Highway.

(b) Subject to Section 225.021(c), the department shall:

(1) design and construct markers indicating the designation as the Ranger Stanley K. Guffey Memorial Highway and any other appropriate information; and

1 (2) erect a marker at each end of the highway and at
2 appropriate intermediate sites along the highway.

3 Sec. 225.219. TROOPER MILTON ALEXANDER MEMORIAL HIGHWAY.

4 (a) The portion of Interstate Highway 35 in the municipal limits of
5 Hillsboro is designated as the Trooper Milton Alexander Memorial
6 Highway.

7 (b) Subject to Section 225.021(c), the department shall:

8 (1) design and construct markers indicating the
9 designation as the Trooper Milton Alexander Memorial Highway and
10 any other appropriate information; and

11 (2) erect a marker at each end of the highway and at
12 appropriate intermediate sites along the highway.

13 Sec. 225.220. TROOPER ERNESTO ALANIS MEMORIAL HIGHWAY. (a)
14 The portion of Interstate Highway 2 in the municipal limits of
15 McAllen is designated as the Trooper Ernesto Alanis Memorial
16 Highway.

17 (b) Subject to Section 225.021(c), the department shall:

18 (1) design and construct markers indicating the
19 designation as the Trooper Ernesto Alanis Memorial Highway and any
20 other appropriate information; and

21 (2) erect a marker at each end of the highway and at
22 appropriate intermediate sites along the highway.

23 Sec. 225.221. TROOPER HOLLIS S. LACY MEMORIAL HIGHWAY. (a)
24 The portion of U.S. Highway 377 in the municipal limits of Denton is
25 designated as the Trooper Hollis S. Lacy Memorial Highway.

26 (b) Subject to Section 225.021(c), the department shall:

27 (1) design and construct markers indicating the

1 designation as the Trooper Hollis S. Lacy Memorial Highway and any
2 other appropriate information; and

3 (2) erect a marker at each end of the highway and at
4 appropriate intermediate sites along the highway.

5 Sec. 225.222. TROOPER HOWARD JORDAN MEMORIAL HIGHWAY. (a)
6 The portion of U.S. Highway 67 in the municipal limits of Texarkana
7 is designated as the Trooper Howard Jordan Memorial Highway.

8 (b) Subject to Section 225.021(c), the department shall:

9 (1) design and construct markers indicating the
10 designation as the Trooper Howard Jordan Memorial Highway and any
11 other appropriate information; and

12 (2) erect a marker at each end of the highway and at
13 appropriate intermediate sites along the highway.

14 SECTION 2. This Act takes effect September 1, 2023.
