## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the establishment of a family health aide program;
3	requiring an occupational license.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 531, Government Code, is amended by
6	adding Subchapter T to read as follows:
7	SUBCHAPTER T. FAMILY HEALTH AIDE PROGRAM
8	Sec. 531.801. DEFINITIONS. (a) In this subchapter:
9	(1) "Home and community support services agency" means
10	a person licensed under Chapter 142, Health and Safety Code.
11	(2) "Licensed health aide" means a person who is:
12	(A) the parent, legal guardian, or family member
13	of a recipient participating in the program;
14	(B) licensed under the program to assist in
15	providing private duty nursing services; and
16	(C) employed by the home and community support
17	services agency providing services to the recipient.
18	(3) "Private duty nursing services" means nursing
19	services provided under the Texas Health Steps comprehensive care
20	program to a recipient enrolled in the STAR Kids Medicaid managed
21	care program.
22	(4) "Program" means the family health aide program
23	established under this subchapter.
2/	Sec 531 802 FAMILY HEALTH AIDE DROCRAM The commission

- 1 in consultation with the Texas Board of Nursing and the STAR Kids
- 2 Managed Care Advisory Committee, shall develop and implement a
- 3 family health aide program to enable a parent, legal guardian, or
- 4 family member of a recipient receiving private duty nursing
- 5 services in a home setting to assist in providing those services as
- 6 a licensed health aide.
- 7 Sec. 531.803. PROGRAM ELIGIBILITY. An individual is
- 8 eligible to participate in the program if:
- 9 (1) the recipient is:
- 10 (A) enrolled in the STAR Kids Medicaid managed
- 11 care program; and
- 12 (B) eligible to receive private duty nursing
- 13 services under the Texas Health Steps comprehensive care program;
- 14 (2) the recipient's parent, legal guardian, or family
- 15 member, as defined by commission rule, elects to participate in the
- 16 program; and
- 17 (3) the home and community support services agency
- 18 that employs the professional registered nurse providing private
- 19 duty nursing services to the recipient agrees to employ the
- 20 recipient's parent, legal guardian, or family member.
- 21 Sec. 531.804. RECIPIENT SCREENING AND NOTIFICATION. The
- 22 commission shall:
- 23 (1) add criteria to any screening tool or other
- 24 instrument used to conduct an assessment or reassessment of a
- 25 recipient under the STAR Kids Medicaid managed care program to
- 26 identify recipients who are eligible to participate in the program;
- 27 and

- 1 (2) notify the parent or legally authorized
- 2 representative of the recipient of the potential availability of
- 3 the program.
- 4 Sec. 531.805. HEALTH AIDE LICENSE REQUIRED. (a) To assist
- 5 in providing private duty nursing services to a recipient under the
- 6 program, a parent, legal guardian, or other family member of the
- 7 recipient must hold a license under this subchapter. An applicant
- 8 for a license under this subchapter must:
- 9 (1) submit an application to the commission in the
- 10 form and manner the commission prescribes; and
- 11 (2) satisfy all training, testing, and other minimum
- 12 qualification standards the commission establishes.
- 13 (b) Notwithstanding any other law, the executive
- 14 commissioner shall, in consultation with the Texas Board of
- 15 Nursing, adopt rules and procedures for issuing a license and for
- 16 renewing, suspending, or revoking a license issued under this
- 17 subchapter. The rules must:
- 18 (1) provide that the commission establish minimum
- 19 qualification standards and, subject to Section 531.806, training
- 20 requirements for obtaining and maintaining the license;
- 21 (2) provide that the commission issue the license
- 22 <u>under this subchapter; and</u>
- 23 (3) prescribe procedures for accepting complaints and
- 24 conducting investigations of alleged violations of the terms of the
- 25 licensure by license holders.
- Sec. 531.806. TRAINING PROGRAM. (a) The commission shall
- 27 develop or approve a health aide training program. The program must

- 1 (b) A licensed health aide may only provide health services
- 2 to a recipient if the services are:
- 3 (1) delegated to the health aide by the professional
- 4 registered nurse providing private duty nursing services to the
- 5 <u>recipient;</u>
- 6 (2) performed under the supervision of that nurse;
- 7 (3) consistent with Texas Board of Nursing rules
- 8 governing the delegation of nursing tasks by a registered
- 9 professional nurse and federal law and regulations governing the
- 10 provision of private duty nursing services under Medicaid,
- 11 including 42 C.F.R. Section 440.80;
- 12 (4) consistent with the recipient's plan of care; and
- 13 (5) authorized by commission rules.
- 14 Sec. 531.808. LICENSED HEALTH AIDE REGISTRY. The
- 15 commission shall establish and maintain a registry of health aides
- 16 <u>licensed under this subchapter.</u>
- 17 Sec. 531.809. HOME AND COMMUNITY SUPPORT SERVICES AGENCIES
- 18 OUTREACH. The commission shall:
- 19 (1) provide information about the program to home and
- 20 community support services agencies that provide private duty
- 21 nursing services under the STAR Kids Medicaid managed care program;
- 22 and
- 23 (2) encourage agencies to employ health aides licensed
- 24 under this subchapter.
- Sec. 531.810. REIMBURSEMENT FOR LICENSED HEALTH AIDE
- 26 SERVICES. The commission shall reimburse a home and community
- 27 support services agency for services provided to a recipient by a

- 1 licensed health aide under this subchapter at a rate that is at
- 2 <u>least equal to the current Medicare low utilization payment</u>
- 3 adjustment visit rates for this state. Reimbursement for the
- 4 services is subject to an enhanced reimbursement rate of a
- 5 certified nursing assistant. The commission shall administer
- 6 reimbursement based on billing units.
- 7 Sec. 531.811. RULES. The executive commissioner shall
- 8 adopt rules necessary to implement this subchapter.
- 9 SECTION 2. The commission shall implement the family health
- 10 aide program established under Subchapter T, Chapter 531,
- 11 Government Code, as added by this Act, not later than September 1,
- 12 2024.
- 13 SECTION 3. If before implementing any provision of this Act
- 14 a state agency determines that a waiver or authorization from a
- 15 federal agency is necessary for implementation of that provision,
- 16 the agency affected by the provision shall request the waiver or
- 17 authorization and may delay implementing that provision until the
- 18 waiver or authorization is granted.
- 19 SECTION 4. This Act takes effect September 1, 2023.
