12	(b) Subject to Subsections (c) and (d), to be eligible for
13	the adjustment, a person must be, on the effective date of the
14	adjustment and disregarding any forfeiture of benefits under
15	Section 824.601, an annuitant eligible to receive:
16	(1) a standard service or disability retirement
17	annuity payment;
18	(2) an optional service or disability retirement
19	annuity payment as either a retiree or beneficiary;
20	(3) an annuity payment under Section 824.402(a)(3) or
21	<u>(4);</u>
22	(4) an annuity payment under Section 824.502; or
23	(5) an alternate payee annuity payment under Section

cost-of-living adjustment in accordance with this section. 1 2 (b) Effective September 1 of each sixth year, the board of trustees shall recompute the amount of a monthly benefit described 3 by Section 824.703(b) for each annuitant who was eligible for the 4 benefit on August 31 of the state fiscal year preceding the date of 5 6 the adjustment. The amount of the adjustment made under this section is equal to the adjustment prescribed by Section 7 824.7<u>03(e)(2)</u>. 8 SECTION 2. This Act takes effect immediately if it receives 9 a vote of two-thirds of all the members elected to each house, as 10 provided by Section 39, Article III, Texas Constitution. If this 11 Act does not receive the vote necessary for immediate effect, this 12

Act takes effect September 1, 2023.
