7 amended by adding Section 501.0167 to read as follows: Sec. 501.0167. NOTICE TO HEALTH AND HUMAN SERVICES 8 COMMISSION REGARDING PUBLIC BENEFITS PROGRAMS. (a) At least 45 9 days but not more than 60 days before an inmate is discharged or 10 released on parole, mandatory supervision, or conditional pardon, 11 the department shall notify the Health and Human Services 12 Commission of the inmate's upcoming discharge or release for 13 purposes of applying for public benefits programs as provided by 14 Section 531.0241805. 15

16 (b) The notice provided under Subsection (a) must include 17 the date that the inmate will be discharged or released.

18 (c) The department shall coordinate with the Health and 19 <u>Human Services Commission to determine:</u>

20 (1) the method to be used by the department to provide
21 the notice required under Subsection (a); and

22 (2) the time, place, and manner for providing
23 application assistance and conducting an eligibility interview, as
24 applicable.

2 (f) The executive commissioner, in consultation with the 3 <u>Texas Department of Criminal Justice, shall adopt rules to</u> 4 implement this section.

5 SECTION 3. If before implementing any provision of this Act 6 a state agency determines that a waiver or authorization from a 7 federal agency is necessary for implementation of that provision, 8 the agency affected by the provision shall request the waiver or 9 authorization and may delay implementing that provision until the 10 waiver or authorization is granted.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2023.
