8	(b) The executive council shall set the standards to qualify
9	for a license under this section. Except as provided by Subsection
10	(b-1), [The] standards must include:
11	(1) satisfaction of minimum recognized graduate
12	degree requirements;
13	(2) completion of graduate course work at a regionally
14	accredited institution of higher education in:
15	(A) psychological foundations;
16	(B) educational foundations;
17	(C) interventions;
18	(D) assessments; and
19	(E) professional issues and ethics;
20	(3) completion of at least 1,200 hours of supervised
21	experience;
22	(4) receipt of a passing score on a nationally
23	recognized qualifying examination determined to be appropriate by

- 2 (5) satisfaction of the requirements under Sections
- $3 \quad 501.2525(a)(3)-(9)$.
- 4 (b-1) The executive council by rule shall provide for the
- 5 issuance of a license under this section to a person who:
- 6 (1) is licensed as a psychologist under this chapter;
- 7 (2) has received a passing score on a nationally
- 8 recognized qualifying examination determined to be appropriate by
- 9 the executive council and on any other examination required by the
- 10 <u>executive council;</u>
- 11 (3) applies for the license in the manner prescribed
- 12 by the executive council; and
- 13 (4) pays the fee set by the executive council.
- 14 (d) The executive council by rule shall establish
- 15 continuing education requirements for a psychologist who holds a
- 16 license under this section, including continuing education
- 17 coursework in an amount and frequency established by the executive
- 18 council that is related to:
- 19 (1) the Individuals with Disabilities Education Act
- 20 (20 U.S.C. Section 1400 et seq.);
- 21 (2) Section 504, Rehabilitation Act of 1973 (29 U.S.C.
- 22 Section 794);
- 23 (3) special education evaluations; and
- 24 (4) school-based psychological services.
- 25 SECTION 2. The Texas Behavioral Health Executive Council
- 26 shall adopt rules and fees necessary to implement Sections
- 27 501.260(b-1) and (d), Occupations Code, as added by this Act, not
