A BILL TO BE ENTITLED

1	AN ACT
2	relating to the establishment of an adult high school pilot program
3	for certain inmates and defendants in the Texas Department of
4	Criminal Justice.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle G, Chapter 493, Government Code is
7	amended by adding Section 493.035 to read as follows:
8	Sec. 493.035. ADULT HIGH SCHOOL PILOT PROGRAM. (a) The
9	department shall establish a pilot program under which one or more
10	nonprofit entities provide an adult education program under
11	Subchapter G, Chapter 12, Education Code, to enable inmates
12	described by Subsection (b) to successfully complete a high school
13	program that can lead to a diploma.
14	(b) An inmate who is at least 26 years of age and not more
15	than 50 years of age is eligible to enroll in an adult high school
16	program operated under the pilot program if:
17	(1) the inmate:
18	(A) has failed to complete the curriculum
19	requirements for high school graduation; or
20	(B) has failed to perform satisfactorily on an
21	assessment instrument required for high school graduation; and
22	(2) the department approves the inmate's enrollment in
23	the program after:
24	(A) assessing the inmate's suitability for

- 2 assessment instrument adopted under Section 501.0921; and
- 3 (B) evaluating the inmate's conduct while in the
- 4 custody of the department.
- 5 (c) In admitting inmates to an adult high school education
- 6 program operated under the pilot program, the nonprofit entity
- 7 shall give priority to an inmate who has not earned a high school
- 8 equivalency certificate.
- 9 (d) The department shall issue a request for proposals from
- 10 nonprofit entities described by Section 12.256, Education Code, to
- 11 provide an adult high school education program under the pilot
- 12 program. The department shall require that each applicant identify
- 13 each region of this state in which the applicant is able to operate
- 14 an adult high school education program under this pilot program.
- 15 <u>(e) The department shall contract with at least one</u>
- 16 qualified applicant to operate an adult high school education
- 17 program under the pilot program.
- 18 (f) The department, in consultation with each nonprofit
- 19 entity that the department contracts with under this section, shall
- 20 identify at least three and not more than five facilities operated
- 21 by the department that are suitable to serve as sites for the pilot
- 22 program.
- SECTION 2. Not later than December 31, 2023, the Texas
- 24 Department of Criminal Justice shall issue the request for
- 25 proposals required by Section 493.035(d), Government Code, as added
- 26 by this Act. Not later than September 1, 2024, the Texas Department
- 27 of Criminal Justice shall ensure that at least one adult high school

- 1 education program required by Section 493.035, Government Code, as
- 2 added by this Act, be in operation in a facility operated by the
- 3 department.
- 4 SECTION 3. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2023.
