A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of tenant legal services offices by local
3	governments to assist low-income residential tenants in eviction
4	cases and in cases involving discrimination based on the tenants'
5	disabilities.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle C, Title 5, Local Government Code, is
8	amended by adding Chapter 181 to read as follows:
9	CHAPTER 181. TENANT LEGAL SERVICES OFFICE
10	Sec. 181.001. DEFINITIONS. In this chapter:
11	(1) "Brief legal assistance" means individualized
12	legal assistance provided in a single consultation by a tenant
13	legal services office to a tenant.
14	(2) "Disability" has the meaning assigned by Section
15	301.003, Property Code.
16	(3) "Full legal representation" means ongoing legal
17	services provided by a tenant legal services office to a tenant,
18	including court filings and appearances and other legal advice,
19	advocacy, or assistance associated with a tenant's case.
20	(4) "Indigent" means having earnings that are not more
21	than 200 percent of the income standard established by applicable
22	federal poverty guidelines.
23	(5) "Local government" means a municipality or county
24	or any combination of municipalities or counties.

No. 4771 "Low-income" means having earnings that are not 1 (6) 2 more than 400 percent of the income standard established by 3 applicable federal poverty guidelines. 4 (7) "Reasonable accommodation" is a change, exception, or adjustment to a rule, policy, practice, or service 5 that may be necessary for a tenant with disabilities to have an 6 7 equal opportunity to use and enjoy a dwelling, including public and 8 common use spaces. 9 (8) "Reasonable modification" means a reasonable 10 structural change made to existing premises that may be necessary for a tenant with disabilities to have full enjoyment of a dwelling, 11 12 including public and common use spaces. Sec. 181.002. TENANT LEGAL SERVICES OFFICE. (a) A local 13 government may create a tenant legal services office to provide 14 15 legal representation and services to tenants as provided by 16 Subsection (b). 17 (b) A tenant legal services office may provide: (1) full legal representation to a tenant: 18 19 (A) in a residential eviction case if the tenant 20 is indigent; or 21 (B) in a case involving a violation of Section 301.025, Property Code, if the tenant is a low-income individual 22 23 with a disability; or 24 (2) brief legal assistance to a tenant in a residential eviction case if the tenant is a low-income individual 25 who is not indigent. 26 27 (c) A local government may establish a department of the

local government or by contract may designate a nonprofit 1 2 corporation to serve as the tenant legal services office for the 3 local government. 4 (d) Any combination of municipalities or counties may agree 5 by entering into an interlocal contract under Chapter 791, Government Code, to jointly implement or administer a tenant legal 6 7 services office under this chapter. 8 (e) A local government by ordinance, order, or interlocal contract may adopt rules and procedures necessary to implement this 9 10 chapter. Sec. 181.003. PROPOSALS BY NONPROFIT CORPORATIONS. (a) 11 12 Before contracting with a nonprofit corporation to serve as a tenant legal services office, a local government shall solicit 13 14 proposals for the office. 15 (b) A local government shall require a written plan from a 16 nonprofit corporation proposing to serve as a tenant legal services 17 office. 18 (c) The written plan must include: 19 (1) a budget for the tenant legal services office, including salaries; 20 21 (2) a description of each personnel position, including the director of legal services position; 22 23 (3) the maximum allowable caseload for each attorney 24 employed by the office; (4) provisions for personnel training; 25 26 (5) a description of anticipated overhead costs for 27 the office; and

1 (6) a policy to ensure that the director of legal services and other attorneys employed by the office do not provide 2 representation to a tenant if doing so would create a conflict of 3 interest that has not been waived by the client. 4 5 (d) After considering each proposal submitted by a nonprofit corporation to a local government under this section, the 6 local government shall select a proposal that reasonably 7 demonstrates that the proposed tenant legal services office will 8 provide adequate quality representation for tenants in disputes 9 10 described by Section 181.002(b). (e) The total cost of a proposal may not be the sole 11 12 consideration in selecting the proposal. Sec. 181.004. DIRECTOR OF LEGAL SERVICES. A tenant legal 13 14 services office must be directed by a director of legal services 15 who: 16 (1) is a member of the State Bar of Texas; 17 (2) has practiced law for at least three years; and (3) has substantial experience in the practice of 18 landlord-tenant law. 19 Sec. 181.005. FUNDING. (a) A tenant legal services office 20 21 is entitled to receive funds for personnel costs and expenses incurred in operating the office in amounts determined by the local 22 government and paid out of the appropriate local fund. 23 24 (b) This chapter does not authorize a local government to disburse, administer, or otherwise allocate funds received by the 25 26 local government from the basic civil legal services account established under Section 51.943, Government Code, to create or 27

2	Sec. 181.006. EMPLOYEES. (a) A tenant legal services
3	office may employ attorneys and other personnel necessary to
4	perform the duties of the office as specified by the local
5	government.
6	(b) The director of a tenant legal services office must
7	designate at least one employee of the office to assist tenants with
8	disabilities in obtaining compliance with laws that apply to
9	housing for tenants with disabilities.
10	Sec. 181.007. DENIAL OF REPRESENTATION. A tenant legal
11	services office may not represent a tenant if:
12	(1) a conflict of interest exists that has not been
13	waived by the client;
14	(2) the office has insufficient resources to provide
15	adequate representation for the tenant;
16	(3) the office is incapable of providing
17	representation for the tenant in accordance with the rules of
18	professional conduct; or
19	(4) the office shows other good cause for not
20	accepting the request for representation by the tenant.
21	Sec. 181.008. INVESTIGATION OF FINANCIAL CONDITION. A
22	tenant legal services office may investigate the financial
23	condition of a tenant who requests representation by the office.
24	Sec. 181.009. PUBLIC HEARING. (a) The director of a tenant
25	legal services office shall hold an annual public hearing to
26	receive recommendations about the office.
27	(b) Not later than the 30th day before the date of the

2	(1) provide notice of the hearing:
3	(A) to each interested party and official; and
4	(B) by publishing the notice in a newspaper of

withdrew;
(5) the expenditures for the office; and
(6) any other information required by the local

SECTION 2. This Act takes effect immediately if it receives
a vote of two-thirds of all the members elected to each house, as
provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2023.
