H.B. No. 4805

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the eligibility of a T20 World Cup match and the T20
3 World Cup tournament for funding under the major events
4 reimbursement program.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 478.0001(3), Government Code, as amended
7 by Chapters 10 (H.B. 1472), 102 (S.B. 1265), 605 (S.B. 1155), and
8 915 (H.B. 3607), Acts of the 87th Legislature, Regular Session,
9 2021, is reenacted and amended to read as follows:
