## A BILL TO BE ENTITLED

1 AN ACT

2 relating to the regulation by the Texas Commission on Environmental

- 3 Quality of certain solid waste processing facilities.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter C, Chapter 361, Health and Safety
- 6 Code, is amended by adding Section 361.127 to read as follows:
- 7 Sec. 361.127. REQUIREMENTS APPLICABLE TO CERTAIN SOLID
- 8 WASTE PROCESSING FACILITIES. (a) This section applies only to a
- 9 solid waste processing facility that salvages, separates,
- 10 dewaters, reclaims, or otherwise processes municipal sludge,
- 11 sewage, septage, grease trap waste, or grit trap waste.
- 12 (b) An owner or operator of a solid waste processing
- 13 <u>facility must have the consent of and authorization from the owner</u>
- 14 or operator of:
- 15 (1) the wastewater collection system that will receive
- 16 the treated wastewater produced by the processing facility; and
- 17 (2) any wastewater treatment facility that will
- 18 <u>further treat the treated wastewater.</u>
- 19 (c) The commission may not issue, amend, or renew a permit
- 20 under this chapter for a solid waste processing facility unless the
- 21 owner or operator of the processing facility demonstrates to the
- 22 commission's satisfaction that the owner or operator has complied
- 23 with Subsection (b).
- SECTION 2. Section 361.127(c), Health and Safety Code, as

- 1 added by this Act, applies only to a solid waste processing facility
- 2 the owner or operator of which files an application with the Texas
- 3 Commission on Environmental Quality for the issuance, amendment, or
- 4 renewal of a permit on or after the effective date of this Act. A
- 5 solid waste processing facility the owner or operator of which
- 6 filed an application with the commission for the issuance,
- 7 amendment, or renewal of a permit before the effective date of this
- 8 Act is governed by the law as it existed immediately before the
- effective date of this Act, and that law is continued in effect for
- 10 that purpose.
- 11 SECTION 3. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2023.
