BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter C, Chapter 281, Health and Safety Code, is amended by adding Section 281.061 to read as follows:

Sec. 281.061. NUECES COUNTY HOSPITAL DISTRICT; BROKER (1) "Broker" means a person licensed as a broker under Chapter 1101, Occupations Code.

(2) "District" means a person licensed as a broker under District" means a person licensed as a broker under district mean

- (e) If a contract made under Subsection (b) requires broker to list the tract of real property for sale for at least 30 days with a multiple-listing service used by other brokers in the county in which the real property is located, the district, on or after the 30th day after the date the property is listed, may sell the tract of real property to a ready, willing, and able buyer who is produced by any broker with whom the district may contract under Subsection (c) using the multiple-listing service and who submits the most advantageous offer.
- (f) The district must post a notice of intent to sell the 1-59 real property in a newspaper of general circulation, not less than 1-60 once, at least 30 days before the date the district accepts an offer 1-61

<u>or</u> (2) a public official who serves on the Nueces County Commissioners Court.

SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2023.
