Section 531.02444, Government Code, is amended 7 by amending Subsection (a) and adding Subsection (a-1) to read as follows: 8 9 (a) The executive commissioner shall develop and implement: (1) a Medicaid buy-in program for persons with 10 11 disabilities as authorized by the Ticket to Work and Work 12 Incentives Improvement Act of 1999 (Pub. L. No. 106-170) or the Balanced Budget Act of 1997 (Pub. L. No. 105-33); and 13 14 (2) subject to Subsection (a-1) as authorized by the Deficit Reduction Act of 2005 (Pub. L. No. 109-171), a Medicaid 15 16 buy-in program for children with disabilities [that is] described by 42 U.S.C. Section 1396a(cc)(1) whose family incomes do not 17 exceed 300 percent of the applicable federal poverty level. 18 (a-1) The executive commissioner by rule shall increase the 19 maximum family income prescribed by Subsection (a)(2) 20 for determining eligibility for the buy-in program to the maximum 21 family income amount allowable, considering available 22 23 appropriations for that purpose. SECTION 2. Subchapter B, Chapter 531, Government Code, is

(a) Notwithstanding Section 531.0602 or any other law, the commission shall, at the request of the legally authorized representative of a child who is in the first position on the medically dependent children (MDCP) waiver program interest list, conduct a medical necessity assessment of the child to determine the child's eligibility for that waiver program.

20 <u>(b) The commission shall directly conduct a medical</u> 21 <u>necessity assessment of a child under this section and may not</u> 22 <u>contract with a managed care organization or other entity to</u> 23 <u>conduct the assessment.</u>

SECTION 3. (a) Section 531.024441, Government Code, as added by this Act, applies to a request for a disability determination assessment to determine eligibility for the Medicaid buy-in program for children made on or after the effective date of

2 (b) Section 531.060111, Government Code, as added by this 3 Act, applies to a request for a medical necessity assessment to 4 determine eligibility for the medically dependent children (MDCP) 5 waiver program made on or after the effective date of this Act.

6 SECTION 4. If before implementing any provision of this Act 7 a state agency determines that a waiver or authorization from a 8 federal agency is necessary for implementation of that provision, 9 the agency affected by the provision shall request the waiver or 10 authorization and may delay implementing that provision until the 11 waiver or authorization is granted.

12 SECTION 5. This Act takes effect September 1, 2023.
