9	shall develop a language access plan to increase non-English
10	speakers' access to assistance provided under the health and human
11	services programs the commission administers. The plan must
12	ensure:
13	(1) all of the commission's public written materials,
14	forms, applications, portal application systems, and external
15	communications are translated and orally interpreted into any
16	language spoken by a group in this state with a population of at
17	least 50,000 of which at least 33 percent have limited English
18	proficiency, according to the most recent American Community Survey
19	compiled by the United States Census Bureau, including:
20	(A) English;
21	(B) Spanish;
22	(C) Vietnamese;
23	(D) Korean;
24	(E) Arabic;

1	(F) Mandarin or Cantonese; and
2	(G) traditional and simplified written Chinese;
3	(2) the translated materials, forms, applications,
4	and external communications are available to the public on the
5	commission's Internet website;
6	(3) that groups described by Subdivision (1) are
7	informed about language access rights and services, including the
8	availability of the commission's written translations and oral
9	interpretations by:
10	(A) conducting intentional outreach efforts; and
11	(B) posting translated information and public
12	announcements in public spaces;
13	(4) commission employees are provided training on the
14	language access plan, language access procedures, and expectations
15	related to the access plan; and
16	(5) that quality control and accountability measures
17	are developed to make certain:
18	(A) all translations and interpretations are
19	professional and understandable; and
20	(B) members of the groups described by

24	(b) The commission shall employ at least one language access

(c) The commission may use multilingual commission 1 2 employees or contract with a third party to translate and prepare or provide oral interpretations of the commission's written 3 4 materials, forms, applications, portal application systems, and external communications as required by Subsection (a). 5 6 (d) The executive commissioner may adopt rules necessary to 7 implement this section. 8 SECTION 2. If before implementing any provision of this Act

9 a state agency determines that a waiver or authorization from a 10 federal agency is necessary for implementation of that provision, 11 the agency affected by the provision shall request the waiver or 12 authorization and may delay implementing that provision until the 13 waiver or authorization is granted.
