1-19 A BILL TO BE ENTITLED  
1-20 AN ACT

1-21 relating to the creation of the Springs Hill Special Utility  
1-22 District; authorizing a fee; granting the power of eminent domain.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Subtitle C, Title 6, Special District Local Laws  
1-25 Code, is amended by adding Chapter 7208 to read as follows:

1-26 CHAPTER 7208. SPRINGS HILL SPECIAL UTILITY DISTRICT

1-27 SUBCHAPTER A. GENERAL PROVISIONS

1-28 Sec. 7208.0101. DEFINITIONS. In this chapter:

1-29 (1) "Board" means the district's board of directors.

1-30 (2) "Corporation" means the Springs Hill Water Supply  
1-31 Corporation.

1-32 (3) "Director" means a board member.

1-33 (4) "District" means the Springs Hill Special Utility  
1-34 District.

1-35 Sec. 7208.0102. NATURE OF DISTRICT. The district is a  
1-36 special utility district in Guadalupe and Wilson Counties created  
1-37 under and essential to accomplish the purposes of Section 59,  
1-38 Article XVI, Texas Constitution. The district is created to serve a  
1-39 public use and benefit.

1-40 Sec. 7208.0103. CONFIRMATION ELECTION REQUIRED. If the  
1-41 creation of the district is not confirmed at a confirmation and  
1-42 initial directors' election held before September 1, 2026:

1-43 (1) the district is dissolved on September 1, 2026,  
1-44 except that the district shall:

1-45 (A) pay any debts incurred;

1-46 (B) transfer to Guadalupe or Wilson County, as  
1-47 appropriate, any assets of the district that remain after the  
1-48 payment of debts; and

1-49 (C) maintain the organization of the district  
1-50 until all debts are paid and remaining assets are transferred; and

1-51 (2) this chapter expires September 1, 2027.

1-52 Sec. 7208.0104. APPLICABILITY OF OTHER LAW. Except as  
1-53 otherwise provided by this chapter, Chapters 49 and 65, Water Code,  
1-54 apply to the district.

1-55 Sec. 7208.0105. INITIAL DISTRICT TERRITORY. (a) The  
1-56 district is initially composed of the territory described by  
1-57 Section 2 of the Act enacting this chapter.

1-58 (b) The boundaries and field notes contained in Section 2 of  
1-59 the Act enacting this chapter form a closure. A mistake made in the  
1-60 field notes or in copying the field notes in the legislative process

- 2-1 does not affect the district's:
- 2-2 (1) organization, existence, or validity;
- 2-3 (2) right to issue any type of bond for the purposes
- 2-4 for which the district is created or to pay the principal of and
- 2-5 interest on a bond;
- 2-6 (3) right to impose a tax; or
- 2-7 (4) legality or operation.

2-8 SUBCHAPTER A-1. TEMPORARY PROVISIONS

2-9 Sec. 7208.0151. TEMPORARY DIRECTORS. (a) The temporary

2-10 board of directors of the district is composed of:

- 2-11 (1) James Martin;
- 2-12 (2) Irene Moreno-Ybarra;
- 2-13 (3) Bernard Mueller;
- 2-14 (4) Deborah Magin;
- 2-15 (5) Keith Steffen; and
- 2-16 (6) Michael Andrews.

2-17 (b) Each temporary director shall qualify for office as

2-18 provided by Section 49.055, Water Code.

2-19 (c) If a temporary director fails to qualify for office, the

2-20 temporary directors who have qualified shall appoint a person to

2-21 fill the vacancy. If at any time there are fewer than four

2-22 qualified temporary directors, the Texas Commission on

2-23 Environmental Quality shall appoint the necessary number of

2-24 directors to fill all vacancies on the board.

2-25 (d) Temporary directors serve until the earlier of:

- 2-26 (1) the date initial directors are elected under
- 2-27 Section 7208.0152; or
- 2-28 (2) the date this chapter expires under Section
- 2-29 7208.0103.

2-30 Sec. 7208.0152. CONFIRMATION AND INITIAL DIRECTORS'

2-31 ELECTION. (a) Before September 1, 2026, the temporary directors

2-32 shall hold an election to confirm the creation of the district and

2-33 to elect six initial directors in accordance with Chapters 49 and

2-34 65, Water Code.

2-35 (b) The temporary board of directors shall determine the

2-36 method for determining the initial term of each person on the

2-37 initial board of directors. The terms must be clearly stated on the

2-38 ballot for the confirmation and directors' election.

2-39 (c) Section 41.001(a), Election Code, does not apply to a

2-40 confirmation and directors' election held as provided by this

2-41 section.

2-42 (d) The initial directors shall continue to serve until the

2-43 district directors elected at the first regularly scheduled

2-44 election of directors qualify for office.

2-45 Sec. 7208.0153. TRANSFER OF ASSETS; DISSOLUTION. (a) If the

2-46 creation of the district is confirmed under Section 7208.0152, the

2-47 corporation shall transfer the assets, debts, and contractual

2-48 rights and obligations of the corporation to the district.

2-49 (b) Following the transfer under Subsection (a):

- 2-50 (1) the board of directors of the corporation shall
- 2-51 commence dissolution proceedings of the corporation;
- 2-52 (2) Certificate of Convenience and Necessity No. 10666
- 2-53 is considered to be held by the district; and
- 2-54 (3) the board of directors of the corporation shall
- 2-55 notify:

2-56 (A) the Texas Commission on Environmental

2-57 Quality of the dissolution of the corporation; and

2-58 (B) the Public Utility Commission of Texas of the

2-59 transfer of Certificate of Convenience and Necessity No. 10666 to

2-60 the district.

2-61 (c) On receipt of notice under Subsection (b)(3)(B), the

2-62 Public Utility Commission of Texas shall note in its records that

2-63 Certificate of Convenience and Necessity No. 10666 is held by the

2-64 district and shall reissue the certificate in the name of the

2-65 district without further application, notice, or hearing. A

2-66 person, party, or entity does not have any right of protest,

2-67 objection, or administrative review of the transfer prescribed by

2-68 this section.

2-69 Sec. 7208.0154. EXPIRATION OF SUBCHAPTER. This subchapter

3-1 expires September 1, 2027.

3-2 SUBCHAPTER B. BOARD OF DIRECTORS

3-3 Sec. 7208.0201. DIRECTORS. The district shall be governed  
3-4 by a board of not fewer than 5 and not more than 11 directors,  
3-5 elected in accordance with Section 65.103, Water Code.

3-6 SUBCHAPTER C. POWERS AND DUTIES

3-7 Sec. 7208.0301. GENERAL POWERS. Except as otherwise  
3-8 provided by this chapter, the district has all of the rights,  
3-9 powers, privileges, authority, functions, and duties provided by  
3-10 the general law of this state, including Chapters 49 and 65, Water  
3-11 Code, applicable to special utility districts created under Section  
3-12 59, Article XVI, Texas Constitution.

3-13 Sec. 7208.0302. WATER SERVICE IMPACT FEE. (a) The district  
3-14 may charge an initial water service impact fee that is not greater  
3-15 than the capital recovery fee charged by the corporation on  
3-16 September 1, 2023, under the corporation's tariff.

3-17 (b) Chapter 395, Local Government Code, does not apply to an  
3-18 initial water service impact fee set under Subsection (a).

3-19 (c) The district may increase the water service impact fee  
3-20 authorized under Subsection (a) only as provided by Chapter 395,  
3-21 Local Government Code, as approved by the Texas Commission on  
3-22 Environmental Quality, or as otherwise provided by law.

SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.

(b) The governor, one of the required recipients, has submitted the notice and Act to the Texas Commission on Environmental Quality.

(c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of representatives within the required time.

(d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

SECTION 4. (a) If this Act does not receive a two-thirds vote of all the members elected to each house, Subchapter C, Chapter 7208, Special District Local Laws Code, as added by Section 1 of this Act, is amended by adding Section 7208.0303 to read as follows: Sec. 7208.0303. NO EMINENT DOMAIN POWER. The district may not exercise the power of eminent domain.

(b) This section is not intended to be an expression of a legislative interpretation of the requirements of Section 17(c), Article I, Texas Constitution.

SECTION 5. This Act takes effect September 1, 2023.
