## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the administration, powers, territory, and financing of
- 3 the Garfield Municipal Utility District No. 1.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 776, Acts of the 78th Legislature,
- 6 Regular Session, 2003, is amended by adding Section 5A to read as
- 7 follows:
- 8 SECTION 5A. EXCLUDED LAND. The following land is excluded
- 9 from the territory of the district:
- 10 Approximately 402.839 acres of land, consisting of the
- 11 following tracts:
- 12 Tract 1: a 267.792 acre portion of that parcel of land
- described by metes and bounds in Section 15(g) of this Act;
- 14 Tract 2: being a 135.047 acre portion of that parcel of land
- 15 described by metes and bounds in Section 15(h) of this Act.
- 16 SECTION 2. Chapter 776, Acts of the 78th Legislature,
- 17 Regular Session, 2003, is amended by adding Sections 7A, 7B, 7C, 7D,
- 18 and 7E to read as follows:
- 19 SECTION 7A. AUTHORITY FOR ROAD PROJECTS. Under Section 52,
- 20 Article III, Texas Constitution, the district may design, acquire,
- 21 construct, finance, issue bonds for, improve, operate, maintain,
- 22 and convey to this state, a county, or a municipality for operation
- 23 and maintenance macadamized, graveled, or paved roads, or
- 24 improvements, including storm drainage, in aid of those roads.

- 1 SECTION 7B. ROAD STANDARDS AND REQUIREMENTS. (a) A road
- 2 project must meet all applicable construction standards, zoning and
- 3 subdivision requirements, and regulations of each municipality in
- 4 whose corporate limits or extraterritorial jurisdiction the road
- 5 project is located.
- 6 (b) If a road project is not located in the corporate limits
- 7 or extraterritorial jurisdiction of a municipality, the road
- 8 project must meet all applicable construction standards,
- 9 subdivision requirements, and regulations of each county in which
- 10 the road project is located.
- 11 <u>(c)</u> If the state will maintain and operate the road, the
- 12 Texas Transportation Commission must approve the plans and
- 13 specifications of the road project.
- 14 SECTION 7C. AUTHORITY TO ISSUE BONDS AND OTHER OBLIGATIONS
- 15 FOR ROAD PROJECTS. The district may issue bonds or other
- 16 obligations payable wholly or partly from ad valorem taxes, impact
- 17 fees, revenue, contract payments, grants, or other district money,
- 18 or any combination of those sources, to pay for a road project
- 19 authorized by Section 7A of this Act. At the time of issuance, the
- 20 total principal amount of bonds or other obligations issued or
- 21 incurred to finance road projects and payable from ad valorem taxes
- 22 may not exceed one-fourth of the assessed value of the real property
- 23 <u>in the district.</u>
- 24 SECTION 7D. TAXES FOR ROAD PROJECT BONDS. At the time the
- 25 district issues bonds payable wholly or partly from ad valorem
- 26 taxes for a road project authorized by Section 7A of this Act, the
- 27 board shall provide for the annual imposition of a continuing

- 1 direct ad valorem tax, without limit as to rate or amount, while all
- 2 or part of the bonds are outstanding as required and in the manner
- 3 provided by Sections 54.601 and 54.602, Water Code.
- 4 SECTION 7E. ELECTIONS REGARDING ROAD PROJECT BONDS. The
- 5 district may not issue bonds payable from ad valorem taxes to
- 6 finance a road project unless the issuance is approved by a vote of
- 7 <u>a two-thirds majority of the district voters voting at an election</u>
- 8 held for that purpose.
- 9 SECTION 3. Section 11(a), Chapter 776, Acts of the 78th
- 10 Legislature, Regular Session, 2003, is amended to read as follows:

- 9 (8) N  $43^{\circ}23'23''$  E a distance of 328.55 feet to the POINT OF
- 10 BEGINNING and containing 135.047 acres of land, more or less.
- 11 SECTION 6. As soon as practicable after the effective date
- 12 of this Act, the temporary board of the Garfield Municipal Utility
- 13 District No. 1 shall hold an election to confirm the establishment
- 14 of the district and to elect five initial directors as provided by
- 15 Section 12, Chapter 776, Acts of the 78th Legislature, Regular
- 16 Session, 2003, as amended by this Act.
- 17 SECTION 7. (a) The legal notice of the intention to
- 18 introduce this Act, setting forth the general substance of this
- 19 Act, has been published as provided by law, and the notice and a
- 20 copy of this Act have been furnished to all persons, agencies,
- 21 officials, or entities to which they are required to be furnished
- 22 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 23 Government Code.
- (b) The governor, one of the required recipients, has
- 25 submitted the notice and Act to the Texas Commission on
- 26 Environmental Quality.
- 27 (c) The Texas Commission on Environmental Quality has filed

- 1 its recommendations relating to this Act with the governor, the
- 2 lieutenant governor, and the speaker of the house of
- 3 representatives within the required time.
- 4 (d) All requirements of the constitution and laws of this
- 5 state and the rules and procedures of the legislature with respect
- 6 to the notice, introduction, and passage of this Act are fulfilled
- 7 and accomplished.
- 8 SECTION 8. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2023.
