A BILL TO BE ENTITLED

AN ACT

2 relating to the election, terms, and resignation of the board of3 commissioners of the Brazoria Drainage District No. 4.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 7(a), Chapter 991, Acts of the 74th 6 Legislature, Regular Session, 1995, is amended to read as follows:

7 (a) The district is managed by a board of three commissioners as provided by Chapter 56, Water Code, and each holds 8 an elected office designated as Place No. 1, Place No. 2, or Place 9 No. 3. The board shall call and hold elections for the appropriate 10 11 number of commissioners on the uniform election date in May [November] of each even-numbered year. Notwithstanding Section 12 56.063, Water Code, the commissioners serve staggered four-year 13 14 terms, each beginning June [January] 1 of the year following the commissioner's election and continuing until the commissioner's 15 successor in office is elected and has qualified. 16

SECTION 2. Chapter 991, Acts of the 74th Legislature, Regular Session, 1995, is amended to add Section 7(a-1) to read as follows:

20 (a-1) If a commissioner announces his candidacy, or shall in 21 fact become a candidate, in any general, special, or primary 22 election, for any office of profit or trust under the laws of this 23 State or the United States other than the office of commissioner of 24 the board of this district, such announcement or candidacy shall

1 constitute an automatic resignation from office.

2 SECTION 3. Sections 7(b), (c), (d), (e), and (i), Chapter 3 991, Acts of the 74th Legislature, Regular Session, 1995, are 4 repealed.

5 SECTION 4. (a) The Brazoria Drainage District No. 4 shall 6 hold the first election to elect commissioners for Place No. 1 and 7 Place No. 2 as described by Section 7(a), Chapter 991, Acts of the 8 74th Legislature, Regular Session, 1995, as amended by this Act, on 9 the uniform election date in May 2024.

10 (b) The Brazoria Drainage District No. 4 shall hold the 11 first election to elect the commissioner for Place No. 3 as 12 described by Section 7(a), Chapter 991, Acts of the 74th 13 Legislature, Regular Session, 1995, as amended by this Act, on the 14 uniform election date in May 2026.

15 (c) The terms of the commissioners currently serving on the 16 board of commissioners for Place No. 1 and Place No. 2 on the 17 effective date of this Act expire on the later of January 1, 2025 or 18 the date the commissioners elected under Subsection (a) of this 19 section have qualified.

20 (d) The term of the commissioner currently serving on the 21 board of commissioners for Place No. 3 on the effective date of this 22 Act expires on the later of January 1, 2027 or the date the 23 commissioner elected under Subsection (b) of this section has 24 qualified.

25 SECTION 5. (a) The legal notice of the intention to 26 introduce this Act, setting forth the general substance of this 27 Act, has been published as provided by law, and the notice and a

copy of this Act have been furnished to all persons, agencies,
officials, or entities to which they are required to be furnished
under Section 59, Article XVI, Texas Constitution, and Chapter 313,
Government Code.

5 (b) The governor, one of the required recipients, has 6 submitted the notice and Act to the Texas Commission on 7 Environmental Quality.

8 (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the 9 10 lieutenant governor, and the speaker of the house of representatives within the required time. 11

12 (d) All requirements of the constitution and laws of this 13 state and the rules and procedures of the legislature with respect 14 to the notice, introduction, and passage of this Act are fulfilled 15 and accomplished.

16 SECTION 6. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2023.
