## RESOLUTION

1 WHEREAS, May is Mental Health Awareness Month, and this 2 occasion provides a fitting opportunity to promote better understanding of issues regarding mental health and to foster 3 support for individuals who are affected by mental illness; and 4 5 WHEREAS, Mental illness encompasses a range of health conditions that influence a person's thoughts, feelings, behavior, 6 7 and mood; these conditions include depression, psychosis, and various disorders, all of which have the potential to profoundly 8 impact an individual's life and relationships; research suggests 9 that mental illness is associated with multiple causes, including 10 11 genetics, environmental factors, exposure to traumatic events, and 12 biochemical processes; and 13 WHEREAS, According to the National Alliance on Mental 14 Illness, 1 in every 5 American adults and 1 in every 6 American youth experience mental illness each year; although early treatment 15 16 can significantly improve wellness and recovery outcomes, many people do not seek out the help they need due to the stigma 17 18 associated with mental illness, as well as an inability to recognize symptoms and a lack of knowledge about health care 19 resources; depending on each patient's unique 20 experience, 21 treatment may include medication, therapy, social support, and educational programs; and 22 WHEREAS, More work remains to be done to fight the stigma 23

surrounding mental illness and to highlight the importance of
