A BILL TO BE ENTITLED

2	relating to the powers and duties of the Health and Human Services
3	Commission and the transfer to the commission of certain powers and
4	duties from the Department of Family and Protective Services.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 265, Family Code, is transferred to
7	Title 9, Human Resources Code, redesignated as Chapter 137, Human
8	Resources Code, and amended to read as follows:
9	CHAPTER 137 [265]. FAMILY SUPPORT [PREVENTION AND EARLY
10	INTERVENTION] SERVICES
11	SUBCHAPTER A. FAMILY SUPPORT [PREVENTION AND EARLY INTERVENTION]
12	SERVICES
13	Sec. $\underline{137.001}$ [$\underline{265.001}$]. DEFINITIONS. In this chapter:
14	(1) "At-risk family" means a family with at least one
15	child and at least one of the following:
16	(A) a child in the family has been the subject of
17	an investigation of abuse, neglect, or exploitation by the
18	Department of Family and Protective Services;
19	(B) the family is experiencing conditions that
20	increase the likelihood of involvement with the child welfare
21	system, the criminal justice system, or the juvenile justice
22	system; or
23	(C) the family is experiencing other conditions
24	that threaten the self-sufficiency or stability of the family

- 1 ["Department" means the Department of Family and Protective
- 2 Services].
- 3 (2) "Commission" means the Health and Human Services
- 4 Commission ["Division" means the prevention and early intervention
- 5 services division within the department].
- 6 (3) "Executive commissioner" means the executive
- 7 commissioner of the commission.
- 8 <u>(4) "Family support</u> ["Prevention and early
- 9 <u>intervention</u>] services" means programs intended to provide [early]
- 10 intervention and promote safety and stability for children and
- 11 at-risk families [or prevent at-risk behaviors that lead to child
- 12 abuse, delinquency, running away, truancy, and dropping out of
- 13 school].
- 14 Sec. 137.002 [265.002]. FAMILY SUPPORT [PREVENTION AND
- 15 $\frac{\text{EARLY INTERVENTION}}{\text{EARLY INTERVENTION}}$ SERVICES [$\frac{\text{DIVISION}}{\text{DIVISION}}$]. (a) The $\frac{\text{commission}}{\text{commission}}$
- 16 [department] shall:
- 17 (1) administer contracts [operate a division] to
- 18 provide family support services to [for] children and [in] at-risk
- 19 [situations and for the] families;
- 20 (2) [of those children and to achieve the
- 21 consolidation of prevention and early intervention services within
- 22 the jurisdiction of a single agency in order to avoid fragmentation
- 23 and duplication of services and to increase the accountability for
- 24 the delivery and administration of these services. The division
- 25 shall be called the prevention and early intervention services
- 26 division and shall have the following duties:
- [$\frac{(1)}{to}$] plan, develop, and administer an integrated

- 1 continuum of care system of programs providing family support
- 2 services to at-risk families [a comprehensive and unified delivery
- 3 system of prevention and early intervention services to children
- 4 and their families in at-risk situations];
- 5 (3) administer the referral, coordination, and
- 6 collaboration of family support services under this chapter with
- 7 similar, existing programs the commission operates;
- 8 (4) $\left[\frac{(2)}{to}\right]$ improve the responsiveness of family
- 9 support services provided to [for at-risk] children and at-risk
- 10 [their] families by facilitating greater coordination and
- 11 flexibility in the use of funds by state and local service
- 12 providers;
- 13 (5) [(3) to] provide greater accountability for
- 14 family support [prevention and early intervention] services in
- 15 order to demonstrate the impact or public benefit of a program by
- 16 adopting outcome measures; and
- 17 (6) $[\frac{4}{to}]$ assist local communities in the
- 18 coordination and development of family support [prevention and
- 19 early intervention] services in order to maximize federal, state,
- 20 and local resources.
- 21 (b) Family support services under this chapter are intended
- 22 <u>to:</u>
- (1) promote healthy outcomes and strengthen support
- 24 systems for children and at-risk families;
- 25 <u>(2) assist at-risk families in achieving</u>
- 26 <u>self-sufficiency and stability;</u>
- 27 (3) promote workforce participation; and

(4) prevent or reduce at-risk behaviors in children 1 and at-risk families, including behaviors that may lead to: 2 (A) child abuse or neglect; 3 4 (B) delinquency, running away, truancy, dropping 5 out of school, or substance abuse; or 6 (C) involvement with the child welfare system, 7 the juvenile justice system, or the criminal justice system [The department's prevention and early intervention services division 8 must be organizationally separate from the department's divisions 9 10 performing child protective services and adult protective services functions]. 11 Sec. 137.003 [265.003]. COORDINATION [CONSOLIDATION] 12 OF [(a)] In order to implement the duties provided in 13 Section 137.002 [265.002], the commission [department] shall 14 15 identify and coordinate with other [consolidate into the division] programs the commission operates with the goal of providing family 16 support services [early intervention or prevention of at-risk 17 behavior that leads to child abuse, delinquency, running away, 18 19 truancy, and dropping out of school]. [(b) The division may provide additional prevention and 20 early intervention services in accordance with Section 265.002. 21 [Sec. 265.004. USE OF EVIDENCE-BASED PROGRAMS FOR AT-RISK 22 FAMILIES. (a) To the extent that money is appropriated for the 23 24 purpose, the department shall fund evidence-based programs, including parenting education, home visitation, family support 25 26 services, mentoring, positive youth development programs, and

crisis counseling, offered by community-based organizations that

27

are designed to prevent or ameliorate child abuse and neglect. The programs funded under this subsection may be offered by a child welfare board established under Section 264.005, a local governmental board granted the powers and duties of a child welfare board under state law, a children's advocacy center established under Section 264.402, or other persons determined appropriate by the department.

- [(a=1) The department shall ensure that not less than 75 percent of the money appropriated for parenting education programs under Subsection (a) funds evidence-based programs or practices described by Section 265.151(b) and that the remainder of that money funds promising programs or practices described by Section 265.151(c) or evidence-informed programs or practices described by Section 265.151(d).
- [(a-2) The department shall actively seek and apply for any available federal funds to support parenting education programs provided under this section.
- [(b) The department shall place priority on programs that
 target children whose race or ethnicity is disproportionately
 represented in the child protective services system.
- [(c) The department shall periodically evaluate the evidence-based abuse and neglect prevention programs to determine the continued effectiveness of the programs.
- [Sec. 265.0041. COLLABORATION WITH INSTITUTIONS OF HIGHER

 EDUCATION. (a) Subject to the availability of funds, the Health

 and Human Services Commission, on behalf of the department, shall

 enter into agreements with institutions of higher education to

- 1 conduct efficacy reviews of any prevention and early intervention
- 2 programs that have not previously been evaluated for effectiveness
- 3 through a scientific research evaluation process.
- 4 [(b) Subject to the availability of funds, the department
- 5 shall collaborate with an institution of higher education to create
- 6 and track indicators of child well-being to determine the
- 7 effectiveness of prevention and early intervention services.
- 8 Sec. 137.004 [$\frac{265.005}{}$]. STRATEGIC PLAN. (a) The
- 9 commission [department] shall develop and implement a five-year
- 10 strategic plan for <u>family support</u> [prevention and early
- 11 intervention] services. Not later than September 1 of the last
- 12 fiscal year in each five-year period, the commission [department]
- 13 shall issue a new strategic plan for the next five fiscal years
- 14 beginning with the following fiscal year.
- 15 (b) A strategic plan required under this section must:
- 16 (1) identify methods to leverage other sources of
- 17 funding or provide support for existing community-based
- 18 [prevention] efforts to provide family support services;
- 19 (2) include a needs assessment that identifies
- 20 programs to best target <u>family supp</u>ort services to the needs of
- 21 <u>underserved</u> [the highest risk] populations and geographic areas;
- 22 (3) identify [the goals and] priorities and specific
- 23 commission actions to coordinate and provide family support
- 24 services to children and at-risk families [for the department's
- 25 overall prevention efforts];
- 26 (4) identify and report on specific outcome
- 27 measurements by obtaining and reporting de-identified aggregate

- 1 data, as permitted by other law, on the number of program
- 2 participants who are:
- 3 (A) involved in the child welfare system, the
- 4 juvenile justice system, or the criminal justice system;
- 5 (B) recipients of other services the commission
- 6 offers; or
- 7 (C) listed in the central registry of the names
- 8 of individuals found to have abused or neglected a child maintained
- 9 under Section 261.002, Family Code [report the results of previous
- 10 prevention efforts using available information in the plan];
- 11 (5) identify additional methods of measuring program
- 12 effectiveness and results or outcomes;
- 13 (6) identify methods to collaborate with other state
- 14 agencies on [prevention] efforts to provide family support
- 15 <u>services</u>;
- 16 (7) identify specific strategies to implement the plan
- 17 and to develop measures for reporting on the overall progress
- 18 toward the plan's goals;
- 19 (8) [identify strategies and goals for increasing the
- 20 number of families receiving prevention and early intervention
- 21 services each year, subject to the availability of funds, to reach
- 22 targets set by the department for providing services to families
- 23 that are eligible to receive services through parental education,
- 24 family support, and community-based programs financed with
- 25 federal, state, local, or private resources; and
- 26 [(9)] identify specific strategies to increase local
- 27 capacity for the delivery of family support [prevention and early

- 1 intervention | services through collaboration with communities and
- 2 stakeholders; and
- 3 (9) address methods for coordinating with other
- 4 commission programs under Section 137.003.
- 5 (c) The commission [department] shall coordinate with
- 6 interested parties and communities in developing the strategic plan
- 7 under this section.
- 8 (d) The commission [department] shall annually review and
- 9 appropriately update the strategic plan developed under this
- 10 section.
- 11 (e) The <u>commission</u> [<u>department</u>] shall post the strategic
- 12 plan developed under this section and any update to the plan on its
- 13 Internet website.
- 14 [Sec. 265.006. PROHIBITION ON USE OF AGENCY NAME OR LOGO.
- 15 The department may not allow the use of the department's name or
- 16 identifying logo or insignia on forms or other materials related to
- 17 the department's prevention and early intervention services that
- 19 [(1) provided by the department's contractors; or
- 20 [(2) distributed by the department's contractors to
- 21 the department's clients.
- 22 [Sec. 265.007. IMPROVING PROVISION OF PREVENTION AND EARLY
- 23 INTERVENTION SERVICES. (a) To improve the effectiveness and
- 24 delivery of prevention and early intervention services, the
- 25 department shall:
- [(1) identify geographic areas that have a high need
- 27 for prevention and early intervention services but do not have

- 2 SUBCHAPTER B. FAMILY SUPPORT SERVICES PROGRAMS FOR CHILD ABUSE AND
- 3 NEGLECT [PRIMARY] PREVENTION [PROGRAMS]
- 4 Sec. 137.051 [265.051]. DEFINITIONS. In this subchapter:
- 5 (1) "Child abuse and neglect prevention" means family
- 6 support services designed to prevent child abuse and neglect before
- 7 the abuse or neglect occurs. The term includes infant mortality
- 8 prevention education programs.
- 9 $\underline{\text{(2)}}$ "Children's trust fund" means a child abuse and
- 10 neglect [primary] prevention program.
- 11 [(2) "Primary prevention" means services and
- 12 activities available to the community at large or to families to
- 13 prevent child abuse and neglect before it occurs. The term includes
- 14 infant mortality prevention education programs.
- 15 (3) "Operating fund" means the commission's
- 16 [Department of Family and Protective Services] child abuse and
- 17 neglect prevention operating fund account.
- 18 (4) "State agency" means a board, commission,
- 19 department, office, or other state agency that:
- 20 (A) is in the executive branch of the state
- 21 government;
- 22 (B) was created by the constitution or a statute
- 23 of this state; and
- 24 (C) has statewide jurisdiction.
- 25 (5) "Trust fund" means the <u>commission's</u> child abuse
- 26 and neglect prevention trust fund account.
- Sec. 137.052 [265.052]. CHILD ABUSE AND NEGLECT [PRIMARY]

- 1 PREVENTION PROGRAMS. (a) The <u>commission</u> [<u>department</u>] shall
- 2 operate the children's trust fund to:
- 3 (1) set policy, offer resources for community
- 4 [primary] prevention programs, and provide information and
- 5 education on family support services and prevention of child abuse
- 6 and neglect;
- 7 (2) develop a state plan for expending funds for child
- 8 abuse and neglect [primary] prevention programs that includes an
- 9 annual schedule of transfers of trust fund money to the operating
- 10 fund;
- 11 (3) develop eligibility criteria for applicants
- 12 requesting funding for child abuse and neglect [primary] prevention
- 13 programs; and
- 14 (4) establish funding priorities for child abuse and
- 15 neglect [primary] prevention programs.
- 16 (b) The children's trust fund shall accommodate the
- 17 commission's [department's] existing rules and policies in
- 18 procuring, awarding, and monitoring contracts and grants.
- 19 (c) The commission [department] may:
- 20 (1) apply for and receive funds made available by the
- 21 federal government or another public or private source for
- 22 administering programs under this subchapter and for funding for
- 23 child abuse and neglect [primary] prevention programs; and
- 24 (2) solicit donations for child abuse and neglect
- 25 [primary] prevention programs.
- Sec. 137.053 [265.053]. ADMINISTRATIVE AND OTHER COSTS.
- 27 (a) Administrative costs under this subchapter during any fiscal

- 1 year may not exceed an amount equal to 50 percent of the interest
- 2 credited to the trust fund during the preceding fiscal year.
- 3 (b) Funds expended under a special project grant from a
- 4 governmental source or a nongovernmental source for public
- 5 education or public awareness may not be counted as administrative
- 6 costs for the purposes of this section.
- 7 Sec. 137.054 [265.054]. CHILD ABUSE AND NEGLECT PREVENTION
- 8 TRUST FUND ACCOUNT. (a) The child abuse and neglect prevention
- 9 trust fund account is an account in the general revenue fund. Money
- 10 in the trust fund is dedicated to child abuse and neglect [primary]
- 11 prevention programs and family support services programs.
- 12 (b) The commission [department] may transfer money
- 13 contained in the trust fund to the operating fund at any time.
- 14 However, during a fiscal year the commission [department] may not
- 15 transfer more than the amount appropriated for the operating fund
- 16 for that fiscal year. Money transferred to the operating fund that
- 17 was originally deposited to the credit of the trust fund under
- 18 Section 118.022, Local Government Code, may be used only for child
- 19 abuse and neglect [primary] prevention programs.
- (c) Interest earned on the trust fund shall be credited to
- 21 the trust fund.
- 22 (d) The trust fund is exempt from the application of Section
- 23 403.095, Government Code.
- (e) All marriage license fees and other fees collected for
- 25 and deposited in the trust fund and interest earned on the trust
- 26 fund balance shall be appropriated each biennium only to the
- 27 operating fund for child abuse and neglect [primary] prevention

- 1 programs and family support services programs.
- 2 Sec. 137.055 [265.055]. COMMISSION [DEPARTMENT] OPERATING
- 3 FUND ACCOUNT. (a) The operating fund is an account in the general
- 4 revenue fund.
- 5 (b) Administrative and other costs allowed in Section
- 6 137.053 [265.053] shall be taken from the operating fund. The
- 7 commission [department] may transfer funds contained in the
- 8 operating fund to the trust fund at any time.
- 9 (c) The legislature may appropriate the money in the
- 10 operating fund to carry out the provisions of this subchapter.
- 11 (d) The operating fund is exempt from the application of
- 12 Section 403.095, Government Code.
- 13 [Sec. 265.056. CONTRIBUTIONS. (a) The department may
- 14 solicit contributions from any appropriate source.
- 15 [(b) Any other contributions for child abuse and neglect
- 16 primary prevention or other prevention and early intervention
- 17 programs shall be deposited into a separate designated fund in the
- 18 state treasury and shall be used for that designated purpose.
- 19 [(c) A person may contribute funds to either the trust fund,
- 20 the operating fund, or a fund designated by the department for a
- 21 specific child abuse and neglect primary prevention or other
- 22 prevention or early intervention purpose.
- 23 [(d) If a person designates that a contribution is intended
- 24 as a donation to a specific fund, the contribution shall be
- 25 deposited in the designated fund.
- Sec. $\underline{137.056}$ [$\underline{265.057}$]. COMMUNITY YOUTH DEVELOPMENT
- 27 GRANTS. (a) Subject to available funding, the commission

- 16 Sec. 137.102 [265.102]. OPERATION OF NURSE-FAMILY
- 17 PARTNERSHIP COMPETITIVE GRANT PROGRAM. (a) The commission
- 18 [department] shall operate a nurse-family partnership competitive
- 19 grant program for [through which] the commission to [department
- 20 will award grants for the implementation of nurse-family
- 21 partnership programs, or the expansion of existing programs, and
- 22 for the operation of those programs for a period of not less than
- 23 two years.

- 5 Sec. 137.103 [265.103]. PARTNERSHIP PROGRAM REQUIREMENTS.
- 6 A partnership program funded through a grant awarded under this
- 7 subchapter must:
- 8 (1) strictly adhere to the program model developed by
- 9 the Nurse-Family Partnership National Service Office, including
- 10 any clinical, programmatic, and data collection requirements of
- 11 that model;
- 12 (2) require that registered nurses regularly visit the
- 13 homes of low-income, first-time mothers participating in the
- 14 program to provide services designed to:
- 15 (A) improve pregnancy outcomes;
- 16 (B) improve child health and development;
- 17 (C) improve family economic self-sufficiency and
- 18 stability; [and]
- 19 (D) reduce the incidence of child abuse and
- 20 neglect;
- 21 (E) increase workforce participation; and
- 22 (F) reduce reliance on state and federal public
- 23 <u>assistance programs;</u>
- 24 (3) require that nurses who provide services through
- 25 the program:
- 26 (A) receive training from the office of the
- 27 attorney general at least once each year on procedures by which a

- 1 person may voluntarily acknowledge the paternity of a child and on
- 2 the availability of child support services from the office;
- 3 (B) provide a mother with information about the
- 4 rights, responsibilities, and benefits of establishing the
- 5 paternity of her child, if appropriate;
- 6 (C) provide assistance to a mother and the
- 7 alleged father of her child if the mother and alleged father seek to
- 8 voluntarily acknowledge paternity of the child, if appropriate; and
- 9 (D) provide information to a mother about the
- 10 availability of child support services from the office of the
- 11 attorney general; and
- 12 (4) require that the regular nurse visits described by
- 13 Subdivision (2) begin not later than a mother's 28th week of
- 14 gestation and end when her child reaches two years of age.
- 15 Sec. 137.104 [$\frac{265.104}{1}$]. APPLICATION. (a) A public or
- 16 private entity, including a county, municipality, or other
- 17 political subdivision of this state, may apply for a grant under
- 18 this subchapter.
- 19 (b) To apply for a grant, an applicant must submit a written
- 20 application to the commission [department] on a form prescribed by
- 21 the commission [department] in consultation with the Nurse-Family
- 22 Partnership National Service Office.
- 23 (c) The application [prescribed by the department] must:
- 24 (1) require the applicant to provide data on the
- 25 number of low-income, first-time mothers residing in the community
- 26 in which the applicant proposes to operate or expand a partnership
- 27 program and provide a description of existing services available to

describe the ongoing monitoring and evaluation 2 3 process to which a grant recipient is subject under Section 137.107 [265.109], including the recipient's obligation to collect and 4 provide information requested by the commission [department] under 5 Section 137.107(c) [265.109(c)]; and 6 require the applicant to provide other relevant 7 (3) 8 information as determined by the commission [department]. [Sec. 265.105. ADDITIONAL CONSIDERATIONS IN AWARDING 9 GRANTS. In addition to the factors described by Sections 10 265.102(b) and 265.103, in determining whether to award a grant to 11 12 an applicant under this subchapter, the department shall consider: [(1) the demonstrated need for a partnership program 13 14 in the community in which the applicant proposes to operate or 15 expand the program, which may be determined by considering: [(A) the poverty rate, the crime rate, the number 16 17 of births to Medicaid recipients, the rate of poor birth outcomes, and the incidence of child abuse and neglect during a prescribed 18 19 period in the community; and 20 [(B) the need to enhance school readiness in the community; 21 [(2) the applicant's ability to participate in ongoing 22 monitoring and performance evaluations under Section 265.109, 23 24 including the applicant's ability to collect and provide information requested by the department under Section 265.109(c); 25 26 [(3) the applicant's ability to adhere partnership program standards adopted under Section 265.106; 27

- 11 subchapter. The standards must be consistent with [adhere to] the
- 12 Nurse-Family Partnership National Service Office program model
- 13 standards and guidelines that were developed in multiple,
- 14 randomized clinical trials and have been tested and replicated in
- 15 multiple communities.
- 16 Sec. $\underline{137.106}$ [$\underline{265.107}$]. USE OF AWARDED GRANT FUNDS. The
- 17 grant funds awarded under this subchapter may be used only to cover
- 18 costs related to implementing or expanding and operating a
- 19 partnership program, including costs related to:
- 20 (1) administering the program;
- 21 (2) training and managing registered nurses who
- 22 participate in the program;
- 23 (3) paying the salaries and expenses of registered
- 24 nurses who participate in the program;
- 25 (4) paying for facilities and equipment for the
- 26 program; and
- 27 (5) paying for services provided by the Nurse-Family

- 1 Partnership National Service Office to ensure a grant recipient
- 2 adheres to the organization's program model.
- 3 [Sec. 265.108. STATE NURSE CONSULTANT. Using money
- 4 appropriated for the competitive grant program, the department
- 5 shall hire or contract with a state nurse consultant to assist grant
- 6 recipients with implementing or expanding and operating the
- 7 partnership programs in the applicable communities.
