4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Sections 51.20(a), (b), (c), and (d), Family

Code, are amended to read as follows:

7 (a) At any stage of the proceedings under this title,

including when a child is initially detained in a pre-adjudication

secure detention facility or a post-adjudication secure

correctional facility, the juvenile court may, at its discretion or

11 at the request of the child's parent or guardian, order a child who

12 is referred to the juvenile court or who is alleged by a petition or

13 found to have engaged in delinquent conduct or conduct indicating a

14 need for supervision to be examined by a disinterested expert,

15 including a physician, psychiatrist, or psychologist, qualified by

16 education and clinical training in mental health or intellectual

17 and developmental disabilities [mental retardation] and

18 experienced in forensic evaluation, to determine whether the child

19 has a mental illness as defined by Section 571.003, Health and

20 Safety Code, is a person with an intellectual disability [mental

21 retardation as defined by Section 591.003, Health and Safety Code,

22 or suffers from chemical dependency as defined by Section 464.001,

23 Health and Safety Code. If the examination is to include a

24 determination of the child's fitness to proceed, an expert may be

- 2 qualified under Subchapter B, Chapter 46B, Code of Criminal
- 3 Procedure, to examine a defendant in a criminal case, and the
- 4 examination and the report resulting from an examination under this

- 6 Chapter 46B, Code of Criminal Procedure, for the examination and
- 7 resulting report of a defendant in a criminal case.
- 8 (b) If, after conducting an examination of a child ordered
- 9 under Subsection (a) and reviewing any other relevant information,
- 10 there is reason to believe that the child has a mental illness or <u>an</u>

- 13 to the local mental health <u>authority</u> or <u>local intellectual and</u>
- 14 developmental disability [mental retardation] authority or to

- 18 (c) If, while a child is under deferred prosecution
- 19 supervision or court-ordered probation, a qualified professional

- 12 [MENTAL RETARDATION] AUTHORITY. A juvenile probation officer shall
- 13 refer a child who has been determined to have a mental illness or an
- 14 <u>intellectual disability</u> [mental retardation] to an appropriate
- 15 local mental health <u>authority</u> or <u>local intellectual and</u>
- 16 <u>developmental disability</u> [mental retardation] authority at least
- 17 three months before the child is to complete the child's juvenile
- 18 probation term unless the child is currently receiving treatment
- 19 from the local mental health <u>authority</u> or <u>local intellectual and</u>
- 20 <u>developmental disability</u> [mental retardation] authority of the
- 21 county in which the child resides.
- SECTION 3. Section 58.0051(a)(2), Family Code, is amended

- 24 (2) "Juvenile service provider" means a governmental
- 25 entity that provides juvenile justice or prevention, medical,
