AN ACT

- 2 relating to the measures to encourage eligible students to claim
- 3 certain tuition and fee exemptions at public institutions of higher
- 4 education for students who are or have been in foster or other

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 54.366(b), Education Code, is amended to
- 8 read as follows:
- 9 (b) The Texas Education Agency and the Texas Higher
- 10 Education Coordinating Board shall develop outreach programs to
- 11 ensure that students in the conservatorship of the Department of
- 12 Family and Protective Services and in grades 9 through 12 [9-12] are
- 13 aware of the availability of the exemption from the payment of
- 14 tuition and fees provided by this section. The outreach programs
- 15 must include the provision of informational materials regarding the
- 16 exemption to each:
- 17 (1) residential child-care facility as defined by
- 18 <u>Section 42.002</u>, Human Resources Code;
- 19 (2) foster parent or relative or other designated
- 20 caregiver for a student enrolled in grade 9 through 12; and
- 21 (3) school district, open-enrollment charter school,
- 22 and private school offering grade nine or above.
- SECTION 2. Section 54.367(b), Education Code, is amended to
- 24 read as follows:

- 1 (b) The Texas Education Agency and the Texas Higher
- 2 Education Coordinating Board shall develop outreach programs to
- 3 ensure that adopted students in grades 9 through 12 [9-12] formerly
- 4 in foster or other residential care are aware of the availability of
- 5 the exemption from the payment of tuition and fees provided by this
- 6 section. The outreach programs must include the provision of
- 7 informational materials regarding the exemption to each:
- 8 (1) residential child-care facility as defined by
- 9 Section 42.002, Human Resources Code;
- 10 (2) adoptive parent of a student in grade 9 through 12
- 11 who was formerly in foster or other residential care; and
- 12 (3) school district, open-enrollment charter school,
- 13 and private school offering grade nine or above.
- 14 SECTION 3. Subchapter D, Chapter 54, Education Code, is
- 15 amended by adding Section 54.3671 to read as follows:
- 16 Sec. 54.3671. STREAMLINED ELIGIBILITY DETERMINATION AND
- 17 APPLICATION PROCESS FOR CERTAIN STUDENTS. The Texas Higher
- 18 Education Coordinating Board and the Department of Family and
- 19 Protective Services shall jointly design and implement a
- 20 streamlined eligibility determination and application process for
- 21 the tuition and fee exemptions provided by Sections 54.366 and
- 22 54.367. The streamlined process must:
- 23 (1) be designed to decrease the administrative burden
- 24 on the department and students in determining exemption eligibility
- 25 by reducing data collection, data entry, and the copying and
- 26 recopying of applications;
- 27 (2) include a system through which a student may apply

- 1 for an exemption electronically through the department's Internet
- 2 website; and
- 3 (3) for a student determined by the department to be
- 4 eligible for an exemption, provide for the automatic submission by
- 5 the department to the institution of higher education indicated by
- 6 the student of the tuition waiver letter or other documentation
- 7 required by the institution to verify the student's eligibility.
- 8 SECTION 4. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2023.
