A BILL TO BE ENTITLED

1 AN ACT 2 relating to increasing the criminal penalty for the offense of 3 criminal mischief involving impairment of a motor fuel pump. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 28.03(b), Penal Code, is amended to read 5 6 as follows: 7 (b) Except as provided by Subsections (f) and (h), an offense under this section is: 8 (1) a Class C misdemeanor if: 9 the amount of pecuniary loss is less than 10 (A) \$100; or 11 12 (B) except as provided in Subdivision (3)(A) or 13 (3)(B), it causes substantial inconvenience to others; 14 (2) a Class B misdemeanor if the amount of pecuniary 15 loss is \$100 or more but less than \$750; (3) a Class A misdemeanor if: 16 17 (A) the amount of pecuniary loss is \$750 or more but less than \$2,500; or 18 the actor causes in whole or 19 (B) in part impairment or interruption of any public water supply, or causes to 20 be diverted in whole, in part, or in any manner, including 21 22 installation or removal of any device for any such purpose, any public water supply, regardless of the amount of the pecuniary 23 24 loss;

1 (4) a state jail felony if the amount of pecuniary loss 2 is: \$2,500 or more but less than \$30,000; 3 (A) less than \$2,500, if the property damaged or 4 (B) destroyed is a habitation and if the damage or destruction is caused 5 by a firearm or explosive weapon; 6 less than \$2,500, if the property was a fence 7 (C) used for the production or containment of: 8 9 (i) cattle, bison, horses, sheep, swine, goats, exotic livestock, or exotic poultry; or 10 11 (ii) game animals as that term is defined by Section 63.001, Parks and Wildlife Code; or 12 less than \$30,000 and the actor: 13 (D) causes wholly or partly impairment or 14 (i) interruption of property used for flood control purposes or a dam or 15 16 of public communications, public transportation, public gas or power supply, or other public service; or 17 18 (ii) causes to be diverted wholly, partly, or in any manner, including installation or removal of any device 19 20 for any such purpose, any public communications or public gas or 21 power supply; 22 (5) a felony of the third degree if: the amount of the pecuniary loss is \$30,000 23 (A) 24 or more but less than \$150,000; 25 (B) the actor, by discharging a firearm or other weapon or by any other means, causes the death of one or more head of 26 27 cattle or bison or one or more horses; [or]

(C) the actor causes wholly or partly impairment
 or interruption of access to an automated teller machine,
 regardless of the amount of the pecuniary loss; or

4 (D) the actor causes wholly or partly impairment
5 or disruption to a retail motor fuel pump, regardless of the amount
6 of pecuniary loss;

7 (6) a felony of the second degree if the amount of
8 pecuniary loss is \$150,000 or more but less than \$300,000; or

9 (7) a felony of the first degree if the amount of 10 pecuniary loss is \$300,000 or more.

SECTION 2. The change in law made by this Act applies only 11 to an offense committed on or after the effective date of this Act. 12 An offense committed before the effective date of this Act is 13 governed by the law in effect on the date the offense was committed, 14 and the former law is continued in effect for that purpose. 15 For 16 purposes of this section, an offense was committed before the 17 effective date of this Act if any element of the offense occurred 18 before that date.
