4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Title 2, Health and Safety Code, is amended by
6	adding Subtitle J to read as follows:
7	SUBTITLE J. PAYMENT FOR HEALTH CARE SERVICES AND SUPPLIES
8	CHAPTER 185. HEALTH CARE BILLING
9	Sec. 185.001. DEFINITIONS. In this chapter:
10	(1) "Debt collection" has the meaning assigned by
11	Section 392.001, Finance Code.
12	(2) "Health care provider" means an individual or
13	facility licensed, certified, or otherwise authorized to provide
14	health care services or supplies in this state in the ordinary
15	course of business or professional practice, including a physician
16	or a hospital.
17	(3) "Health care service" means a service a health
18	care provider provides to an individual to diagnose, prevent,
19	treat, alleviate, cure, or heal a human health condition, illness,
20	injury, or disease.
21	Sec. 185.002. ITEMIZED BILL REQUIRED. (a) A health care
22	provider that requests payment from a patient for a health care
23	service or related supply provided to the patient shall submit with

the request a written, itemized bill of charges for all health care

- 1 services and supplies provided to the patient during the patient's
- 2 visit to the provider.
- 3 (b) The itemized bill must include:
- 4 (1) the amount the health care provider agrees to
- 5 accept as full payment for each health care service and supply that
- 6 provider provided to the patient;
- 7 (2) a plain language description of each distinct
- 8 health care service or supply; and
- 9 (3) if reimbursement is sought from a third party, any
- 10 billing code submitted to the third party and the amounts billed to
- 11 and paid by that third party.
- 12 (c) A health care provider may issue the itemized bill
- 13 electronically, including through a patient portal on the
- 14 provider's Internet website.
- 15 (d) A patient is entitled to obtain from the health care
- 16 provider an itemized bill on request at any time after the itemized
- 17 bill is initially issued under Subsection (a).
- 18 (e) A health care provider may not pursue debt collection
- 19 against a patient for a provided health care service or supply
- 20 unless the provider has complied with this section.
- 21 Sec. 185.003. DISCIPLINARY ACTION BY LICENSING AUTHORITY.
- 22 The appropriate licensing authority may take disciplinary action
- 23 against a health care provider that violates this chapter as if the
- 24 provider violated an applicable licensing law.
- 25 SECTION 2. This Act takes effect September 1, 2023.
