1 (b) The person denied possession or access is entitled to 2 decide the time of the additional possession or access, subject to 3 the provisions of Subsection (a-2)(1) [(a)(1)].

4 (c) Subsection (a-1) does not:

5 (1) create a cause of action against the Department of
6 Family and Protective Services; or

(2) waive sovereign immunity to suit or liability.

8 SECTION 2. The enactment of this Act does not constitute a 9 material and substantial change of circumstances sufficient to 10 warrant modification of a court order or portion of a decree that 11 provides for the possession of or access to a child rendered before 12 the effective date of this Act.

13 SECTION 3. The change in law made by this Act applies only 14 to a suit affecting the parent-child relationship pending before a 15 trial court on or filed on or after the effective date of this 16 Act. A suit affecting the parent-child relationship in which a 17 final order is rendered before the effective date of this Act is 18 governed by the law in effect on the date the order was rendered, 19 and the former law is continued in effect for that purpose.

20 SECTION 4. This Act takes effect September 1, 2023.
