(C) the office is required to show probable cause that the credible allegation of fraud that is the basis of the payment hold has an indicia of reliability and that continuing to pay the provider presents [an ongoing significant financial risk to the state and] a threat to the integrity of Medicaid <u>due to:</u> (i) an ongoing risk that the alleged fraud could result in the provider or another person receiving an

8 <u>unauthorized benefit of more than \$100,000; or</u>
9 <u>(ii) the provider's conduct having resulted</u>
10 <u>in a serious threat to the health or safety of recipients or the</u>

11 possibility that the provider's conduct may result in that serious 12 threat at any time.

13 SECTION 2. If before implementing any provision of this Act 14 a state agency determines that a waiver or authorization from a 15 federal agency is necessary for implementation of that provision, 16 the agency affected by the provision shall request the waiver or 17 authorization and may delay implementing that provision until the 18 waiver or authorization is granted.

19 SECTION 3. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2023.
