(a) Before the commission approves an administrative order
or proposed agreement to settle an administrative enforcement
action initiated under this subchapter to which the commission is a
party, the commission shall:

6 (1) allow the public to comment in writing on the 7 proposed order or agreement;

8 (2) publish notice[- Notice] of the opportunity to 9 comment <u>on the proposed order or agreement</u> [shall be published] in 10 the Texas Register not later than the 30th day before the date on 11 which the public comment period closes; and

12 (3) if required by Subsection (a-1), notify the state 13 representative and state senator who represent the area in which 14 the violation that is the subject of the proposed order or agreement 15 occurred.

16 (a-1) The commission shall:

17 (1) affirmatively offer each state representative and 18 state senator the opportunity to receive notice under Subsection 19 (a)(3); and

20 (2) provide appropriate notice to each representative 21 or senator who elects to receive notice under this section.
