SECTION 3. Section 2161.061, Government Code, is amended by

- 1 adding Subsection (f) to read as follows:
- 2 (f) To be certified by the comptroller as a historically
- 3 underutilized business, a business owned by one or more persons who
- 4 qualify as economically disadvantaged solely based on being a
- 5 person with a disability as defined by 42 U.S.C. Section 12102 must
- 6 submit to the comptroller an affidavit from a physician licensed to
- 7 practice medicine in this state for each owner claiming a
- 8 <u>disability verifying that owner's disability.</u>
- 9 SECTION 4. Section 2161.125, Government Code, is amended to
- 10 read as follows:
- 11 Sec. 2161.125. CATEGORIZATION OF HISTORICALLY
- 12 UNDERUTILIZED BUSINESSES. The comptroller, in cooperation with
- 13 each state agency reporting under this subchapter, shall categorize
- 14 each historically underutilized business included in a report under
- 15 this subchapter by sex, race, and ethnicity and by whether the
- 16 business qualifies as a historically underutilized business
- 17 because it is owned or owned, operated, and controlled, as
- 18 applicable, wholly or partly by one or more persons with a
- 19 disability as defined by 42 U.S.C. Section 12102, one or more
- 20 persons who identify as one or more of the sexual orientations or
- 21 gender identities described by Section 2161.001(3)(A)(viii), or
- 22 one or more veterans as defined by 38 U.S.C. Section 101(2) who have
- 23 suffered at least a 20 percent service-connected disability as
- 24 defined by 38 U.S.C. Section 101(16).
- 25 SECTION 5. This Act takes effect September 1, 2023.
