- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 143.003, Local Government Code, is
- 6 amended by amending Subdivision (1) and adding Subdivision (1-a) to
- 7 read as follows:
- 8 (1) "Business day" means any day that is not a
- 9 Saturday, Sunday, or national holiday described by Section 662.003,
- 10 Government Code.
- 11 (1-a) "Commission" means the Fire Fighters' and Police
- 12 Officers' Civil Service Commission.
- SECTION 2. Sections 143.010(a) and (e), Local Government
- 14 Code, are amended to read as follows:
- 15 (a) Except as otherwise provided by this chapter, if a fire
- 16 fighter or police officer wants to appeal to the commission from an
- 17 action for which an appeal or review is provided by this chapter,
- 18 the fire fighter or police officer need only file an appeal with the
- 19 commission within 10  $\underline{\text{business}}$  days after the date the action
- 20 occurred.
- 21 (e) The affected fire fighter or police officer may request
- 22 the commission to subpoena any books, records, documents, papers,
- 23 accounts, or witnesses that the fire fighter or police officer
- 24 considers pertinent to the case. The fire fighter or police officer

- 1 must make the request before the 10th <a href="calendar">calendar</a> day before the date
- 2 the commission hearing will be held. If the commission does not
- 3 subpoena the material, the commission shall, before the third
- 4 calendar day before the date the hearing will be held, make a
- 5 written report to the fire fighter or police officer stating the
- 6 reason it will not subpoena the requested material. This report
- 7 shall be read into the public record of the commission hearing.
- 8 SECTION 3. Section 143.014, Local Government Code, is
- 9 amended by amending Subsection (d) and adding Subsection (d-1) to
- 10 read as follows:
- 11 (d) Except as provided by Subsection (d-1), a [A] person
- 12 appointed to a position in the classification immediately below
- 13 that of the head of the police department must:
- 14 (1) be employed by the municipality's police
- 15 department as a sworn police officer;
- 16 (2) have at least two years' continuous service in that
- 17 department as a sworn police officer; and
- 18 (3) meet the requirements for appointment as head of a
- 19 police department prescribed by Section 143.013(b).
- 20 (d-1) The head of a police department may appoint a person
- 21 that does not meet the requirements described by Subsections (d)(1)
- 22 and (2) to a position in the classification immediately below that
- 23 of the head of the police department if:
- 24 (1) the head of the police department requests and is
- 25 granted approval for the appointment from the governing body of the
- 26 municipality; and
- 27 (2) the head of the police department provides a

- 1 justification for hiring outside of the department to the
- 2 commission and the commission determines that:
- 3 (A) the justification is valid; and
- 4 (B) the appointment will improve the
- 5 department's operations.
- 6 SECTION 4. Section 143.015, Local Government Code, is
- 7 amended by amending Subsections (a) and (b) and adding Subsections
- 8 (a-1) and (b-1) to read as follows:
- 9 (a) Except for a decision by the commission to suspend a
- 10 police officer for not more than 15 calendar days, [Hf] a fire
- 11 fighter or police officer <u>may appeal</u> [is dissatisfied with] any
- 12 commission decision by filing [, the fire fighter or police officer
- 13 may file] a petition in district court asking that the decision be
- 14 set aside. The petition must:
- 15 <u>(1)</u> be filed within 10 <u>business</u> days after the date the
- 16 <u>fire fighter or police officer is notified of the</u> final commission
- 17 decision; and [+
- [(1) is sent to the fire fighter or police officer by
- 19 certified mail; or]
- 20 (2) <u>if filed by a police officer, establish that the</u>
- 21 <u>commission decision was arbitrary, unreasonable, not in accordance</u>
- 22 with commission rules, or not in accordance with applicable law [is
- 23 personally received by the fire fighter or police officer or by that
- 24 person's designee].
- 25 <u>(a-1)</u> For purposes of Subsection (a)(1), a fire fighter or
- 26 police officer is considered notified on the date the final
- 27 commission decision is:

- 1 (1) sent to the fire fighter or police officer by
- 2 certified mail; or
- 3 (2) personally received by the fire fighter or police
- 4 officer or by that person's designee.
- 5 (b) Except as provided by Subsection (b-1), an [An] appeal
- 6 under this section is by trial de novo. The district court may
- 7 grant the appropriate legal or equitable relief necessary to carry
- 8 out the purposes of this chapter. The relief may include
- 9 reinstatement or promotion with back pay if an order of suspension,
- 10 dismissal, or demotion is set aside.
- 11 (b-1) If the district court determines a petition by a
- 12 police officer does not fulfill the requirements of Subsection
- 13 (a)(2), the district court shall dismiss the petition.
- 14 SECTION 5. Section 143.016, Local Government Code, is
- 15 amended to read as follows:
- Sec. 143.016. PENALTY FOR <u>FAILURE TO COMPLY WITH SUBPOENA</u>
- 17 AND CERTAIN VIOLATIONS [<del>VIOLATION</del>] OF CHAPTER. (a) A fire fighter
- 18 or police officer commits an offense if the person:
- 19 (1) fails to respond to a subpoena issued under
- 20 Section 143.009; or
- 21 <u>(2)</u> violates <u>Section 143.086 or 143.087</u> [this
- 22 chapter].
- 23 (b) An offense under this section [or Section 143.009] is a
- 24 Class C misdemeanor [punishable by a fine of not less than \$10 or
- 25 more than \$100, confinement in the county jail for not more than 30
- 26 days, or both fine and confinement].
- 27 SECTION 6. Section 143.024(a), Local Government Code, is

- 1 amended to read as follows:
- 2 (a) Before the 10th day before the date an entrance
- 3 examination is held, the commission shall cause a notice of the
- 4 examination to be posted in plain view in a conspicuous location [on
- 5 a bulletin board located] in the main lobby of the city hall and in
- 6 the commission's office. The notice must show the position to be
- 7 filled or for which the examination is to be held, and the date,
- 8 time, and place of the examination.
- 9 SECTION 7. Sections 143.025(d) and (e), Local Government
- 10 Code, are amended to read as follows:
- 11 (d) Examinations for beginning positions [in the fire
- 12 department] may be held at different locations if each applicant
- 13 takes the same examination and is examined in the presence of other
- 14 applicants.
- 15 (e) This subsection applies only in a municipality to which
- 16 Subchapter J does not apply. An examination for beginning
- 17 positions in the police department must be held at one or more
- 18 locations in the municipality in which the police department is
- 19 located and may be held at additional locations outside the
- 20 municipality. An examination held at multiple locations must be
- 21 administered on the same day  $[\frac{\text{and at the same time}}{}]$  at each location
- 22 at which it is given. Only one eligibility list for a police
- 23 department may be created from that examination, and only one
- 24 eligibility list may be in effect at a given time. Each applicant
- 25 who takes the examination for the eligibility list shall:
- 26 (1) take the same examination; and
- 27 (2) be examined in the presence of other applicants

- 1 for that eligibility list.
- 2 SECTION 8. Section 143.029(b), Local Government Code, is
- 3 amended to read as follows:
- 4 (b) Before the 30th day before the date a promotional
- 5 examination is held, the commission shall post a notice of the
- 6 examination in a conspicuous location [plain view on a bulletin
- 7 board located] in the main lobby of the city hall and in the
- 8 commission's office. The notice must show the position to be filled
- 9 or for which the examination is to be held, and the date, time, and
- 10 place of the examination. The commission shall also furnish
- 11 sufficient copies of the notice for posting in the stations or
- 12 subdepartments in which the position will be filled.
- 13 SECTION 9. The heading to Section 143.030, Local Government
- 14 Code, is amended to read as follows:
- 15 Sec. 143.030. ELIGIBILITY FOR FIRE DEPARTMENT PROMOTION AND
- 16 PROMOTIONAL EXAMINATION.
- 17 SECTION 10. Section 143.030, Local Government Code, is
- 18 amended by amending Subsection (b) and adding Subsections (b-1),
- 19 (g), and (h) to read as follows:
- 20 (b) Except as provided by this section, Section 143.013, and
- 21 Section 143.102, a fire fighter is eligible for promotion if the
- 22 <u>fire fighter has continuously held a position in the classification</u>
- 23 that is immediately below, in salary, the classification for which
- 24 the examination is to be held for at least two years before the
- 25 examination date.
- 26 (b-1) Each promotional examination is open to each fire
- 27 fighter who is eligible under Subsection (b) [at any time has

- 1 continuously held for at least two years a position in the
- 2 classification that is immediately below, in salary, the
- 3 classification for which the examination is to be held].
- 4 (g) A fire fighter is not eligible for promotion to the rank
- 5 of captain or its equivalent unless the fire fighter has at least
- 6 four years of actual service in the fire department for which the
- 7 fire fighter would serve as that rank.
- 8 (h) If a fire fighter is recalled on active military duty
- 9 for not more than 60 months, the two-year service requirement under
- 10 Subsection (b) does not apply and the fire fighter is entitled to
- 11 have time spent on active military duty considered as duty in the
- 12 fire department.
- 13 SECTION 11. The heading to Section 143.031, Local
- 14 Government Code, is amended to read as follows:
- 15 Sec. 143.031. ELIGIBILITY FOR POLICE DEPARTMENT PROMOTION
- 16 AND PROMOTIONAL EXAMINATION.
- 17 SECTION 12. Section 143.031, Local Government Code, is
- 18 amended by amending Subsection (a) and adding Subsections (a-1),
- 19 (d), (e), and (f) to read as follows:
- 20 (a) Except as provided by this section, Section 143.013, and
- 21 Section 143.102, a police officer is eligible for promotion if the
- 22 police officer has continuously held a position in the
- 23 classification that is immediately below, in salary, the
- 24 classification for which the examination is to be held for at least
- 25 two years before the examination date.
- 26 (a-1) Each promotional examination is open to each police
- 27 officer who is eligible under Subsection (a) [for at least two years

- 1 immediately before the examination date has continuously held a
- 2 position in the classification that is immediately below, in
- 3 salary, the classification for which the examination is to be
- 4 held].
- 5 (d) If a police officer is serving in a beginning position
- 6 in a police department, the two-year service period described by
- 7 Subsection (a) begins on completion of the police officer's
- 8 probationary period.
- 9 (e) If a police officer is recalled on active military duty
- 10 for not more than 60 months, the two-year service requirement under
- 11 Subsection (a) does not apply for the period the police officer is
- 12 on active military duty and the police officer is entitled to have
- 13 time spent on active military duty considered as duty in the police
- 14 department.
- 15 <u>(f) A demoted police officer is not eligible for promotion</u>
- 16 unless the police officer has served continuously in the next lower
- 17 position for at least two years after the demotion.
- 18 SECTION 13. Section 143.035(g), Local Government Code, is
- 19 amended to read as follows:
- 20 (g) The commission shall canvass the votes within 30 days
- 21 after the date the election is held. An appeal alleging election
- 22 irregularity must be filed with the commission within five <u>business</u>
- 23 [working] days after the date the election closes. If approved by
- 24 the sworn police officers, the promotional system amendment becomes
- 25 effective after all election disputes have been ruled on and the
- 26 election votes have been canvassed by the commission.
- 27 SECTION 14. Section 143.045(d), Local Government Code, is

- 1 amended to read as follows:
- 2 (d) To facilitate the settlement of the accounts of deceased
- 3 fire fighters and police officers, all unpaid compensation,
- 4 including all accumulated sick leave, due at the time of death to an
- 5 active fire fighter or police officer who dies as a result of a
- 6 line-of-duty injury or illness, shall be paid to the <a href="legal"><u>legal</u></a>
- 7 beneficiary designated in writing by the fire fighter or police
- 8 officer, or, if no legal beneficiary is designated, the person
- 9 determined to be entitled to the payment under Title 2, Estates Code
- 10 [persons in the first applicable category of the following
- 11 prioritized list:
- 12 [(1) to the beneficiary or beneficiaries the fire
- 13 fighter or police officer designated in writing to receive the
- 14 compensation and filed with the commission before the person's
- 15 death;
- 16 [(2) to the fire fighter's or police officer's widow or
- 17 widower;
- 18 [(3) to the fire fighter's or police officer's child
- 19 or children and to the descendants of a deceased child, by
- 20 representation;
- 21 [(4) to the fire fighter's or police officer's parents
- 22 or to their survivors; or
- [(5) to the properly appointed legal representative of
- 24 the fire fighter's or police officer's estate, or in the absence of
- 25 a representative, to the person determined to be entitled to the
- 26 payment under the state law of descent and distribution].
- 27 SECTION 15. Section 143.051, Local Government Code, is

- 1 amended to read as follows:
- 2 Sec. 143.051. CAUSE FOR REMOVAL OR SUSPENSION OF FIRE
- 3 FIGHTERS. A commission rule prescribing cause for removal or
- 4 suspension of a fire fighter [or police officer] is not valid unless
- 5 it involves one or more of the following grounds:
- 6 (1) conviction of a felony or other crime involving
- 7 moral turpitude;
- 8 (2) violations of a municipal charter provision;
- 9 (3) acts of incompetency;
- 10 (4) neglect of duty;
- 11 (5) discourtesy to the public or to a fellow employee
- 12 while the fire fighter [or police officer] is in the line of duty;
- 13 (6) acts showing lack of good moral character;
- 14 (7) drinking intoxicants while on duty or intoxication
- 15 while off duty;
- 16 (8) conduct prejudicial to good order;
- 17 (9) refusal or neglect to pay just debts;
- 18 (10) absence without leave;
- 19 (11) shirking duty or cowardice at fires, if
- 20 applicable; or
- 21 (12) violation of an applicable fire [or police]
- 22 department rule or special order.
- 23 SECTION 16. Subchapter D, Chapter 143, Local Government
- 24 Code, is amended by adding Section 143.0515 to read as follows:
- Sec. 143.0515. CAUSE FOR REMOVAL, SUSPENSION, OR DEMOTION
- 26 OF POLICE OFFICERS. A commission rule prescribing cause for
- 27 removal, suspension, or demotion of a police officer is valid only

- 5 Government Code, is amended to read as follows:
- 6 Sec. 143.052. DISCIPLINARY SUSPENSIONS OF FIRE FIGHTERS.
- 7 SECTION 18. Sections 143.052(b), (c), (d), (e), (f), (g),
- 8 and (h), Local Government Code, are amended to read as follows:
- 9 (b) The head of the fire [or police] department may suspend
- 10 a fire fighter [or police officer] under the department head's
- 11 supervision or jurisdiction for the violation of a civil service
- 12 rule. The suspension may be for a reasonable period not to exceed
- 13 15 calendar days or for an indefinite period. An indefinite
- 14 suspension is equivalent to dismissal from the department.
- 15 (c) If the department head suspends a fire fighter [or
- 16 police officer], the department head shall, within 120 hours after
- 17 the hour of suspension, file a written statement with the
- 18 commission giving the reasons for the suspension. The department
- 19 head shall immediately deliver a copy of the statement in person to
- 20 the suspended fire fighter [or police officer].
- 21 (d) The copy of the written statement must inform the
- 22 suspended fire fighter [or police officer] that if the fire fighter
- 23 [person] wants to appeal to the commission, the fire fighter
- 24 [person] must file a written appeal with the commission within 10
- 25 business days after the date the fire fighter [person] receives the
- 26 copy of the statement.
- (e) The written statement filed by the department head with

- 1 the commission must point out each civil service rule alleged to
- 2 have been violated by the suspended fire fighter [or police
- 3 officer] and must describe the alleged acts of the fire fighter
- 4 [person] that the department head contends are in violation of the
- 5 civil service rules. It is not sufficient for the department head
- 6 merely to refer to the provisions of the rules alleged to have been
- 7 violated.
- 8 (f) If the department head does not specifically point out
- 9 in the written statement the act or acts of the fire fighter [or
- 10  $\frac{\text{police officer}}{\text{police officer}}$ ] that allegedly violated the civil service rules,
- 11 the commission shall promptly reinstate the <u>fire fighter</u> [person].
- 12 (g) If offered by the department head, the fire fighter [or
- 13 police officer] may agree in writing to voluntarily accept, with no
- 14 right of appeal, a suspension of 16 to 90 calendar days for the
- 15 violation of a civil service rule. The fire fighter [or police
- 16 officer] must accept the offer within five business [working] days
- 17 after the date the offer is made. If the  $\underline{\text{fire fighter}}$  [ $\underline{\text{person}}$ ]
- 18 refuses the offer and wants to appeal to the commission, the <u>fire</u>
- 19 fighter [person] must file a written appeal with the commission
- 20 within 15 <u>business</u> days after the date the <u>fire fighter</u> [person]
- 21 receives the copy of the written statement of suspension.
- (h) In the original written statement and charges and in any
- 23 hearing conducted under this chapter, the department head may not
- 24 complain of an act that occurred earlier than the 180th day
- 25 preceding the date the department head suspends the fire fighter
- 26 [or police officer]. If the act is allegedly related to criminal
- 27 activity including the violation of a federal, state, or local law

- 1 for which the fire fighter [or police officer] is subject to a
- 2 criminal penalty, the department head may not complain of an act
- 3 that is discovered earlier than the 180th day preceding the date the
- 4 department head suspends the fire fighter [or police officer]. The
- 5 department head must allege that the act complained of is related to
- 6 criminal activity.
- 7 SECTION 19. Subchapter D, Chapter 143, Local Government
- 8 Code, is amended by adding Section 143.0525 to read as follows:
- 9 Sec. 143.0525. DISCIPLINARY SUSPENSIONS AND DEMOTIONS OF
- 10 POLICE OFFICERS. (a) This section does not apply to a municipality
- 11 with a population of 1.5 million or more.
- (b) For purposes of this section, "civil service rule"
- 13 <u>includes the underlying grounds described by Section 143.0515.</u>
- 14 (c) If the head of a police department determines that a
- 15 police officer under the department head's supervision or
- 16 jurisdiction violated a civil service rule, the department head
- 17 may:
- 18 (1) suspend the police officer for a period not to
- 19 exceed 15 calendar days;
- 20 (2) suspend the police officer indefinitely, which is
- 21  $\underline{\text{equivalent to dismissal from the department; or}}$
- 22 (3) recommend to the commission to demote the police
- 23 officer to any lower rank in the classified civil service.
- 24 (d) If the department head suspends or recommends to demote
- 25 <u>a police officer under this section, the department head shall,</u>
- 26 within five business days after the date of suspension or
- 27 recommended demotion, file a written statement with the commission.

- 1 The written statement must identify each civil service rule alleged
- 2 to have been violated by the police officer and describe the alleged
- 3 acts of the police officer that the department head contends are in
- 4 violation of the civil service rules. It is not sufficient for the
- 5 department head merely to refer to the provisions of the rules
- 6 alleged to have been violated.
- 7 <u>(e) The department head shall deliver a copy of the</u>
- 8 statement in person or by certified mail to the police officer
- 9 within five business days after the date the department head
- 10 suspends or recommends demotion of the police officer. The copy
- 11 must inform the police officer of the police officer's right to
- 12 appeal under Section 143.0535.
- (f) A suspension under this section may go into effect
- 14 immediately.
- 15 (g) A recommended demotion under this section goes into
- 16 <u>effect if the commission grants the request of the department head.</u>
- 17 (h) In the original written statement and charges and in any
- 18 hearing conducted under this chapter, the department head may not
- 19 complain of an act that was discovered by the department before the
- 20 360th day preceding the date the department head suspends or
- 21 recommends demotion of the police officer.
- (i) If the act described by Subsection (h) is allegedly
- 23 related to criminal activity, including the violation of a federal,
- 24 state, or local law for which the police officer is subject to a
- 25 <u>criminal penalty</u>, the department head must allege in the original
- 26 written statement and charges that the act is related to criminal
- 27 activity.

- 1 SECTION 20. The heading to Section 143.053, Local
- 2 Government Code, is amended to read as follows:
- 3 Sec. 143.053. APPEAL OF DISCIPLINARY SUSPENSION OF FIRE
- 4 FIGHTERS.
- 5 SECTION 21. Section 143.053, Local Government Code, is
- 6 amended by amending Subsections (b), (e), (f), and (g) and adding
- 7 Subsection (f-1) to read as follows:
- 8 (b) If a suspended fire fighter [or police officer] appeals
- 9 the suspension to the commission, the commission shall hold a
- 10 hearing and render a decision in writing within 30 days after the
- 11 date it receives notice of appeal. The suspended fire fighter
- 12 [person] and the commission may agree to postpone the hearing for a
- 13 definite period.
- 14 (e) In its decision, the commission shall state whether the
- 15 suspended fire fighter [or police officer] is:
- 16 (1) permanently dismissed from the fire [or police]
- 17 department;
- 18 (2) temporarily suspended from the department; or
- 19 (3) restored to the <u>fire fighter's</u> [<del>person's</del>] former
- 20 position or status in the department's classified service.
- 21 (f) If the commission finds that the period of disciplinary
- 22 suspension should be reduced, the commission may order a reduction
- 23 in the period of suspension. If the suspended fire fighter [or
- 24 police officer] is restored to the position or class of service from
- 25 which the person was suspended, the fire fighter [or police
- 26 officer] is entitled to:
- 27 (1) full compensation for the actual time lost as a

- 1 result of the suspension at the rate of pay provided for the
- 2 position or class of service from which the fire fighter [person]
- 3 was suspended; and
- 4 (2) restoration of or credit for any other benefits
- 5 lost as a result of the suspension in accordance with Subsection
- 6 (f-1), including sick leave, vacation leave, and service credit in
- 7 a retirement system.
- 8 (f-1) Standard payroll deductions, if any, for retirement
- 9 and other benefits restored shall be made from the compensation
- 10 paid under Subsection (f)(1), and the municipality shall make its
- 11 standard corresponding contributions, if any, to the retirement
- 12 system or other applicable benefit systems.
