- (2) "Cyber attack" means an attempt to damage,

1 (3) "Drone" has the meaning assigned by Article 2.33, 2 Code of Criminal Procedure, as added by Chapter 1011 (H.B. 1758), Acts of the 87th Legislature, Regular Session, 2021. 3 (4) "Explosive weapon" has the meaning assigned by 4 5 Section 28.03. (5) "Extended power outage" means a power outage: 6 7 (A) lasting for two hours or more; or (B) affecting 1,000 or more meters used to 8 9 measure electric energy consumption by retail customers. 10 (6) "Firearm" has the meaning assigned by Section 11 46.01. (b) A person commits an offense if, without the effective 12 13 consent of the owner or operator of a critical infrastructure facility, the person: 14 15 (1) intentionally or knowingly damages, destroys, 16 vandalizes, or impairs the function of any critical infrastructure 17 facility; and (2) as a result of the conduct described 18 Subdivision (1), causes an extended power outage. 19 20 (c) An offense under this section is a felony of the second degree, except that the offense is a felony of the first degree if: 21 22 (1) the amount of pecuniary damage to the critical infrastructure facility is \$100,000 or more; or 23 (2) the actor uses a firearm, drone, cyber attack, or 24 25 explosive weapon in the commission of the offense.

(d) If conduct that constitutes an offense under this

- 1 may be prosecuted under this section, the other law, or both.
- 2 SECTION 3. The change in law made by this Act applies only
- 3 to an offense committed on or after the effective date of this Act.
- 4 An offense committed before the effective date of this Act is
- 5 governed by the law in effect on the date the offense was committed,
- 6 and the former law is continued in effect for that purpose. For
- 7 purposes of this section, an offense was committed before the
- 8 effective date of this Act if any element of the offense occurred
- 9 before that date.
- 10 SECTION 4. This Act takes effect September 1, 2023.
