4	obtain a certificate issued by the Texas Commission on Law

6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Section 37.0812, Education Code, is amended by
8	adding Subsection (c) to read as follows:
9	(c) A school district may not contract for the provision of
10	active shooter response training under this section unless the
11	training provider is certified under Section 1701.2515,
12	Occupations Code, to provide the training.
13	SECTION 2. Subchapter E, Chapter 51, Education Code, is
14	amended by adding Section 51.221 to read as follows:
15	Sec. 51.221. ACTIVE SHOOTER TRAINING PROVIDERS. An
16	institution of higher education, as defined by Section 61.003, may
17	not contract for the provision of active shooter training for peace
18	officers commissioned under this subchapter unless the training
19	provider is certified under Section 1701.2515, Occupations Code, to
20	provide the training.
21	SECTION 3. Subchapter F, Chapter 1701, Occupations Code, is
22	amended by adding Section 1701.2515 to read as follows:
23	Sec. 1701.2515. CERTIFICATE REQUIRED TO PROVIDE ACTIVE
24	SHOOTER TRAINING AT PUBLIC SCHOOLS AND INSTITUTIONS OF HIGHER

1	EDUCATION. (a) In this section, "institution of higher education"
2	has the meaning assigned by Section 61.003, Education Code.
3	(b) An individual or a legal entity may not provide active
4	shooter training to peace officers of students or employees at a
5	public primary or secondary school or an institution of higher
6	education unless:
7	(1) the individual providing the instruction is
8	certified by the commission under this section to provide the
9	training; and
10	(2) if the training is provided by a legal entity, both
11	the legal entity and the individual providing the instruction on
12	behalf of the legal entity are certified by the commission under
13	this section to provide the training.
14	(c) The commission shall:
15	(1) establish a certification program for providers of
16	active shooter training, including for individuals and legal
17	entities; and
18	(2) issue a certificate to a provider who meets the
19	qualifications of the program established under Subdivision (1).
20	(d) The commission shall adopt rules for the renewal of a
21	certificate issued under this section. The commission may require
22	continuing education for the renewal of the certificate.
23	SECTION 4. Not later than September 1, 2024, the Texas
24	Commission on Law Enforcement shall establish the certification
25	program required by Section 1701.2515, Occupations Code, as added
26	by this Act.
27	SECTION 5. Sections 37.0812(c) and 51.221, Education Code,

as added by this Act, and Section 1701.2515(b), Occupations Code,
as added by this Act, apply only to active shooter training provided
on or after December 1, 2024.

4 SECTION 6. This Act takes effect September 1, 2023.
