A BILL TO BE ENTITLED

1 AN ACT relating to creating the criminal offense of tampering with an 2 electronic monitoring device and to certain consequences 3 on 4 conviction of that offense. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Chapter 38, Penal Code, is amended by adding 6 Section 38.112 to read as follows: 7 Sec. 38.112. TAMPERING WITH ELECTRONIC MONITORING DEVICE. 8 (a) A person who is required to submit to electronic monitoring of 9 10 the person's location as part of an electronic monitoring program under Article 42.035, Code of Criminal Procedure, or as a condition 11 of community supervision, parole, mandatory supervision, 12 or release on bail commits an offense if the person knowingly removes 13 or disables, or causes or conspires or cooperates with another 14 person to remove or disable, a tracking device that the person is 15 required to wear to enable the electronic monitoring of the 16 17 person's location. (b) An offense under this section is a state jail felony, 18 except that the offense is a felony of the third degree if the 19 person is in the super-intensive supervision program described by 20 Section 508.317(d), Government Code. 21 22 (c) This section does not apply to the removal or disabling of a tracking device by a health care provider, as defined by 23 24 Section 161.201, Health and Safety Code, due to medical necessity.

1 SECTION 2. Article 42.08, Code of Criminal Procedure, is 2 amended by adding Subsection (b-1) to read as follows: 3 (b-1)(1) A judge sentencing a defendant convicted of an offense under Section 38.112, Penal Code, committed while on parole 4 or mandatory supervision may order the sentence for the offense to: 5 6 (A) run concurrently with the sentence for the 7 offense for which the defendant was released on parole or to 8 mandatory supervision; or 9 (B) if the defendant's parole or mandatory supervision has been revoked, commence immediately on completion of 10 11 the sentence for the offense for which the defendant was released on parole or to mandatory supervision. 12 13 (2) A judge who orders a sentence to be imposed consecutively in the manner described by Subdivision (1)(B) shall, 14 on pronouncing the sentence, order the defendant transferred to the 15 16 custody of the Texas Department of Criminal Justice for purposes of serving the applicable sentences consecutively as described by that 17 subdivision if the defendant has not been taken into custody by the 18 department following the revocation of the defendant's parole or 19 20 mandatory supervision. 21 SECTION 3. This Act takes effect September 1, 2023.
