2	(1) creates or causes to be created an altered image;

4	(2) publishes, distributes, or causes to be published
5	or distributed an altered image during the period beginning 90 days

8	(d-2) It is an affirmative defense to prosecution for an
9	offense under Subsection (d-1) if the person includes a clear label
10	on the image stating that the image is altered.

12	(1) "Altered image" means an image that has been
13	manipulated to change the physical appearance of an individual or
14	depict an individual performing an action that did not occur. The
15	term does not include:
16	(A) a cartoon, caricature, or any other image

19	(B) an image altered only to change the

25	SECTION 3. The change in law made by this Act applies only
26	to an offense committed on or after the effective date of this Act.

1 governed by the law in effect on the date the offense was committed,
2 and the former law is continued in effect for that purpose. For
3 purposes of this section, an offense was committed before the
4 effective date of this Act if any element of the offense occurred
5 before that date.

6 SECTION 4. This Act takes effect September 1, 2023.
