Section 2054.061(b), Government Code, is amended to read as follows: 7 The department shall annually analyze: 8 (b) 9 the department's staffing needs; the need for and cost-effectiveness of contracting 10 (2) 11 for consultants and outside staff; 12 (3) whether the department could use department staff to accomplish tasks proposed for the consultants and outside staff; 13 14 [and] 15 (4) whether and what type of training or additional 16 resources are necessary for the department to use the department's own staff to accomplish tasks proposed for the consultants or 17 outside staff; and 18 (5) whether entering into an agreement with a public 19 junior college district under Section 2054.0701 is appropriate to 20 21 assist the department in meeting staffing needs. 22 SECTION 2. Subchapter C, Chapter 2054, Government Code, is 23 amended by adding Section 2054.0701 to read as follows: 24 Sec. 2054.0701. STATE INFORMATION TECHNOLOGY CREDENTIAL.

No. 1201 1 (a) The department may enter into an agreement with a public junior college district under Section 130.0081, Education Code, to offer a 2 program leading to a state information technology credential to 3 address shortages in the state information resources workforce. 4 5 (b) A program offered under this section must: 6 (1) be approved by the Texas Higher Education 7 Coordinating Board in accordance with Section 61.0512, Education 8 Code; 9 (2) develop the knowledge and skills necessary for an 10 entry-level information technology position in a state agency; and 11 (3) include a one-year apprenticeship with: 12 (A) the department; 13 (B) another relevant state agency; 14 (C) an organization working on a major 15 information resources project; or 16 (D) a regional network security center 17 established under Section 2059.202. (c) The executive director shall update the department's 18 19 intra-agency career ladder program to ensure that an associate degree together with a credential awarded under this section may be 20 substituted for a four-year baccalaureate degree. 21 (d) The classification officer in the office of the state 22 auditor shall review the state's position classification plan to 23 24 determine whether an associate degree together with a credential awarded under this section may be substituted for a four-year 25 26 baccalaureate degree and revise relevant job descriptions 27 accordingly.

(e) If a program offered under this section is not fully
funded through tuition and other money of the public junior college
district available for the purpose, the department may:
(1) use any money available to the department for the
purpose to offer a program under this section; and
(2) solicit and accept gifts, grants, and donations
from any public or private source for purposes of offering a program
under this section.
SECTION 3. This Act takes effect September 1, 2023.
