A person 4 satisfies the requirements of this section by reporting information 5 to either the appropriate local health authority or law enforcement 6 7 agency. (d) A report under this section must include, if possible: 8 9 (1) the date and time of the overdose incident; (2) the approximate location of the overdose incident, 10 11 using: 12 (A) an address; 13 (B) the latitude and longitude of the location; 14 or 15 (C) the location data from a cellular device; 16 (3) whether an opioid antagonist was administered, and if so, the number of doses and the type of delivery; and 17 18 (4) whether the overdose was fatal or nonfatal. (e) A person who reports information about an overdose 19 20 incident under this section in good faith is not subject to civil or criminal liability for making the report. 21 22 (f) A law enforcement agency may use information received from a report under this section only for mapping overdose 23 locations for public safety purposes. 24 25 (g) Information in a report described by this section is confidential and not subject to disclosure under Chapter 552, 26 27 Government Code.

SECTION 2. Chapter 370, Local Government Code, is amended
by adding Section 370.007 to read as follows:

3 <u>Sec. 370.007. PARTICIPATION AGREEMENT FOR OVERDOSE</u> 4 <u>MAPPING. (a) A local health authority or law enforcement agency</u> 5 <u>shall enter into a participation agreement with an entity that</u> 6 <u>maintains a computerized system for mapping overdoses of one or</u> 7 <u>more controlled substances for public safety purposes.</u>

(b) A local health authority or law enforcement agency shall 8 provide information received under Section 161.045, Health and 9 Safety Code, to the entity with which the authority or agency has a 10 participation agreement under Subsection (a) for purposes of 11 entering the information into the computerized system. The local 12 13 health authority or law enforcement agency is not required to provide information received under Section 161.045, Health and 14 Safety Code, regarding a controlled substance to the entity with 15 16 which the authority or agency has a participation agreement if the entity does not maintain an overdose map that includes the 17 controlled substance. 18

19 (c) A local health authority or law enforcement agency or an 20 employee of a local health authority or law enforcement agency is 21 not subject to civil or criminal liability for providing 22 information received under Section 161.045, Health and Safety Code, 23 to an entity pursuant to a participation agreement under this 24 section.

25 (d) Information provided to an entity pursuant to a
26 participation agreement under this section is confidential and not
27 subject to disclosure under Chapter 552, Government Code.
