## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the rights of victims of sexual assault and to certain
- 3 procedures and reimbursements occurring with respect to a sexual
- 4 assault or other sex offense.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Article 38.435, Code of Criminal Procedure, is
- 7 amended to read as follows:
- 8 Art. 38.435. PROHIBITED USE OF EVIDENCE FROM FORENSIC
- 9 MEDICAL EXAMINATION PERFORMED ON VICTIM OF SEXUAL
- 10 ASSAULT. Evidence collected during a forensic medical examination
- 11 conducted under Subchapter [For] G, Chapter 56A, may not be used to
- 12 investigate or prosecute a misdemeanor offense, or an offense under
- 13 Subchapter D, Chapter 481, Health and Safety Code, alleged to have
- 14 been committed by the victim from whom the evidence was collected.
- SECTION 2. Article 56A.051(a), Code of Criminal Procedure,
- 16 is amended to read as follows:
- 17 (a) A victim, guardian of a victim, or close relative of a
- 18 deceased victim is entitled to the following rights within the
- 19 criminal justice system:
- 20 (1) the right to receive from a law enforcement agency
- 21 adequate protection from harm and threats of harm arising from
- 22 cooperation with prosecution efforts;
- 23 (2) the right to have the magistrate consider the
- 24 safety of the victim or the victim's family in setting the amount of

- 1 bail for the defendant;
- 2 (3) if requested, the right to be informed:
- 3 (A) by the attorney representing the state of
- 4 relevant court proceedings, including appellate proceedings, and
- 5 to be informed if those proceedings have been canceled or
- 6 rescheduled before the event; and
- 7 (B) by an appellate court of the court's
- 8 decisions, after the decisions are entered but before the decisions
- 9 are made public;
- 10 (4) when requested, the right to be informed:
- 11 (A) by a peace officer concerning the defendant's
- 12 right to bail and the procedures in criminal investigations; and
- 13 (B) by the office of the attorney representing
- 14 the state concerning the general procedures in the criminal justice
- 15 system, including general procedures in guilty plea negotiations
- 16 and arrangements, restitution, and the appeals and parole process;
- 17 (5) the right to provide pertinent information to a
- 18 community supervision and corrections department conducting a
- 19 presentencing investigation concerning the impact of the offense on
- 20 the victim and the victim's family by testimony, written statement,
- 21 or any other manner before any sentencing of the defendant;
- 22 (6) the right to receive information:
- 23 (A) regarding compensation to victims of crime as
- 24 provided by Chapter 56B, including information related to the costs
- 25 that may be compensated under that chapter and the amount of
- 26 compensation, eligibility for compensation, and procedures for
- 27 application for compensation under that chapter;

- 1 (B) for a victim of a sexual assault, regarding 2 the payment under Subchapter G for a forensic medical examination; [under Article 56A.252 for a victim of an alleged sexual assault,] 3 4 and 5 (C) when requested, providing a [to] referral to available social service agencies that may offer additional 6 7 assistance; (7) the right to: 8 9 (A) be informed, on request, of parole procedures; 10 11 (B) participate in the parole process; provide to the board for inclusion in the 12 (C) defendant's file information to be considered by the board before 13 the parole of any defendant convicted of any offense subject to this 14 15 chapter; and
- 16 (D) be notified, if requested, of proceedings concerning a defendant in the victim's case and of the 17 defendant's release; 18
- (8) the right to be provided with a waiting area, 19 separate or secure from other witnesses, including the defendant 20 and relatives of the defendant, before testifying in any proceeding 21 22 concerning the defendant; if a separate waiting area is not available, other safeguards should be taken to minimize the 23 victim's contact with the defendant and the defendant's relatives 24 25 and witnesses, before and during court proceedings;
- (9) the right to the prompt return of any of the 26 27 victim's property that is held by a law enforcement agency or the

- 1 attorney representing the state as evidence when the property is no
- 2 longer required for that purpose;
- 3 (10) the right to have the attorney representing the
- 4 state notify the victim's employer, if requested, that the victim's
- 5 cooperation and testimony is necessary in a proceeding that may
- 6 require the victim to be absent from work for good cause;
- 7 (11) the right to request victim-offender mediation
- 8 coordinated by the victim services division of the department;
- 9 (12) the right to be informed of the uses of a victim
- 10 impact statement and the statement's purpose in the criminal
- 11 justice system as described by Subchapter D, to complete the victim
- 12 impact statement, and to have the victim impact statement
- 13 considered:
- 14 (A) by the attorney representing the state and
- 15 the judge before sentencing or before a plea bargain agreement is
- 16 accepted; and
- 17 (B) by the board before a defendant is released
- 18 on parole;
- 19 (13) for a victim of an assault or sexual assault who
- 20 is younger than 17 years of age or whose case involves family
- 21 violence, as defined by Section 71.004, Family Code, the right to
- 22 have the court consider the impact on the victim of a continuance
- 23 requested by the defendant; if requested by the attorney
- 24 representing the state or by the defendant's attorney, the court
- 25 shall state on the record the reason for granting or denying the
- 26 continuance; and
- 27 (14) if the offense is a capital felony, the right to:

- 1 (A) receive by mail from the court a written
- 2 explanation of defense-initiated victim outreach if the court has
- 3 authorized expenditures for a defense-initiated victim outreach
- 4 specialist;
- 5 (B) not be contacted by the victim outreach
- 6 specialist unless the victim, guardian, or relative has consented
- 7 to the contact by providing a written notice to the court; and
- 8 (C) designate a victim service provider to
- 9 receive all communications from a victim outreach specialist acting
- 10 on behalf of any person.
- SECTION 3. Article 56A.052(a), Code of Criminal Procedure,
- 12 is amended to read as follows:
- 13 (a) If the offense is a sexual assault, a victim, guardian
- 14 of a victim, or close relative of a deceased victim is entitled to
- 15 the following rights within the criminal justice system:
- 16 (1) if requested, the right to a disclosure of
- 17 information regarding:
- 18 (A) any evidence that was collected during the
- 19 investigation of the offense, unless disclosing the information
- 20 would interfere with the investigation or prosecution of the
- 21 offense, in which event the victim, guardian, or relative shall be
- 22 informed of the estimated date on which that information is
- 23 expected to be disclosed; and
- 24 (B) the status of any analysis being performed of
- 25 any evidence described by Paragraph (A);
- 26 (2) if requested, the right to be notified:
- 27 (A) at the time a request is submitted to a crime

- 1 laboratory to process and analyze any evidence that was collected
- 2 during the investigation of the offense;
- 3 (B) at the time of the submission of a request to
- 4 compare any biological evidence collected during the investigation
- 5 of the offense with DNA profiles maintained in a state or federal
- 6 DNA database; and
- 7 (C) of the results of the comparison described by
- 8 Paragraph (B), unless disclosing the results would interfere with
- 9 the investigation or prosecution of the offense, in which event the
- 10 victim, quardian, or relative shall be informed of the estimated
- 11 date on which those results are expected to be disclosed;
- 12 (3) if requested, the right to counseling regarding
- 13 acquired immune deficiency syndrome (AIDS) and human
- 14 immunodeficiency virus (HIV) infection; and
- 15 (4) for the victim, the right to:
- 16 (A) testing for acquired immune deficiency
- 17 syndrome (AIDS), human immunodeficiency virus (HIV) infection,
- 18 antibodies to HIV, or infection with any other probable causative
- 19 agent of AIDS; and
- 20 (B) a forensic medical examination as [to the
- 21 extent] provided by <u>Subchapter</u> [Subchapters F and] G [if, within
- 22 120 hours of the offense:
- [(i) the offense is reported to a law
- 24 enforcement agency; or
- 25 [<del>(ii) a forensic medical examination is</del>
- 26 otherwise conducted at a health care provider].

- 10 in the juvenile justice system, including general procedures

- 14 (B) the appeal of the case;
- 15 (5) the right to provide pertinent information to a
- 16 juvenile court conducting a disposition hearing concerning the
- 17 impact of the offense on the victim and the victim's family by
- 18 testimony, written statement, or any other manner before the court
- 19 renders its disposition;
- 20 (6) the right to receive information:
- 21 (A) regarding compensation to victims as
- 22 provided by Chapter 56B, Code of Criminal Procedure, including
- 23 information relating [related] to the costs that may be
- 24 compensated under that chapter and the amount of compensation,
- 25 eligibility for compensation, and procedures for application for
- 26 compensation under that chapter;
- 27 (B) for a victim of a sexual assault, regarding

- 1 the payment under Subchapter G, Chapter 56A, Code of Criminal
- 2 Procedure, for a forensic medical examination; [of medical expenses
