5	SECTION 1. Section 801.003, Occupations Code, is amended to

7	Sec. 801.003. APPLICATION OF SUNSET ACT. The State Board of
8	Veterinary Medical Examiners is subject to Chapter 325, Government
9	Code (Texas Sunset Act). Unless continued in existence as provided
10	by that chapter, the board is abolished September 1, 2027 [2029].
11	SECTION 2. Chapter 801, Occupations Code, is amended by
12	adding Subchapter A-1 to read as follows:
13	SUBCHAPTER A-1. TEMPORARY REGULATION BY TEXAS DEPARTMENT OF
14	LICENSING AND REGULATION
15	Sec. 801.021. DEFINITIONS. In this subchapter:
16	(1) "Commission" means the Texas Commission of
17	Licensing and Regulation.
18	(2) "Department" means the Texas Department of
19	Licensing and Regulation.
20	Sec. 801.022. TEMPORARY ADMINISTRATION OF CHAPTER BY
21	DEPARTMENT; RULES. (a) Notwithstanding any other law, the
22	department shall assume all policy-making powers of the board and
23	administer this chapter. The department may contract as necessary
24	to administer this chapter.

1 (b) A power or duty granted to the board under this chapter 2 is a power or duty of the executive director of the department, the 3 department, or the commission, as applicable. 4 (c) The commission or executive director of the department may delegate, or withdraw any delegation of, any power or duty under 5 this chapter to the board or the executive director of the board. 6 7 The delegation or withdrawal of delegation must be in writing. (d) Except as provided by Section 801.024(c), the 8 commission shall adopt all rules necessary to implement this 9 10 chapter. (e) Not later than December 31, 2026, the department shall 11 conduct a review under Section 2001.039, Government Code, of each 12 13 rule under 22 T.A.C. Part 24. In conducting the review under this subsection, the department shall ensure that license holders and 14 15 the public have a meaningful opportunity to provide input and 16 recommend changes to the rules. 17 (f) The department shall propose necessary amendments to a rule, or the repeal of a rule, for which the department determines 18 the board lacks a sufficient reason or authority to adopt or 19 20 enforce. (g) For any rulemaking or contested case for which an expert 21 witness is necessary, the commission or department, as applicable, 22 may have a member of the board who is a veterinarian licensed in 23 24 good standing in this state serve as the expert witness. 25 Sec. 801.023. SEPARATION OF ADMINISTRATIVE FUNCTIONS OF BOARD. (a) The executive director of the department shall direct 26 27 and may dismiss the executive director of the board. The presiding

1	officer of the commission shall appoint a replacement executive
2	director of the board if necessary.
3	(b) Subject to Subsection (a), the executive director of the
4	board is responsible for the administration of financial services,
5	human resources, and workforce development duties of the board,
6	including:
7	(1) accounts payable and accounts receivable;
8	(2) budgeting, inventory, and asset management;
9	(3) payroll;
10	(4) personnel and labor issues;
11	(5) purchasing;
12	(6) recruitment, evaluation, selection, training, and
13	promotion of personnel;
14	(7) submitting required reports regarding finances,
15	performance measures, strategic planning, legislative
16	appropriations requests, operating budgets, and similar
17	information as required by law;
18	(8) legal support services, including responding to
19	requests for public information; and
20	(9) information technology and support.
21	(c) If the department provides any of the functions listed
22	in Subsection (b), the board shall reimburse the department for
23	administrative costs incurred in providing those services.
24	Sec. 801.024. ADVISORY BOARD. (a) Notwithstanding
25	Subchapter D, the board is an advisory board to the department.
26	(b) The board, the equine dental provider advisory
27	committee, and any advisory committee appointed under Section

1	801.163 shall provide advice and recommendations to the department
2	on technical matters relevant to the administration of this
3	chapter.
4	(c) The board shall adopt rules relating to the scope of
5	practice of or a health-related standard of care for the practice of
6	the profession of veterinary medicine.
7	(d) The commission shall review each rule adopted under
8	Subsection (c) and, if the commission determines that the rule is
9	not authorized by this chapter or other law or is an unauthorized
10	anticompetitive rule, issue an order stating that determination. A
11	rule for which an order is issued under this subsection may not take
12	effect or be enforced.
13	Sec. 801.025. CONFLICT WITH OTHER LAW. (a)
14	Notwithstanding Section 51.003, to the extent of any conflict
15	between this chapter and Chapter 51, this chapter controls.
16	(b) To the extent of any conflict between this subchapter
17	and another provision of this chapter, this subchapter controls.
18	Sec. 801.026. EXPIRATION. This subchapter expires
19	September 1, 2027.
20	SECTION 3. (a) In this section:
21	(1) "Board" means the State Board of Veterinary
22	Medical Examiners.
23	(2) "Department" means the Texas Department of
24	Licensing and Regulation.
25	(b) Not later than October 1, 2023, the Department of
26	Information Resources shall consult with the department and the
27	board to assess the database needs of the board and establish a plan

1 for the procurement and acquisition of a database suitable to
2 address those needs.

3 (c) Notwithstanding any other law, the board shall provide 4 the Department of Information Resources and the department with 5 access to any system, hardware, software, documents, or information 6 necessary to achieve the purposes of Subsection (b) of this 7 section.

8 (d) The provision of information under this section to the 9 Department of Information Resources or the department does not 10 waive confidentiality or privilege.

SECTION 4. Not later than December 1, 2024, the Texas Department of Licensing and Regulation shall submit to the Sunset Advisory Commission and each standing committee of the legislature with primary jurisdiction over the State Board of Veterinary Medical Examiners any legislative recommendations necessary to improve the board's operations.
